No. MH/MR/South-344/2014-16 rules & regulations, EPTA committee for the academic session 2022-23, was formed on 28th April 2022 through lottery session which was conducted in the presence of Mrs. Shobhana Patil- the Cluster Head fro Education Department, PMC, Pune.

- Thereafter the first meeting was conducted on 9th July 2022 on different issues. The Fee Revision was one of the Agenda Points of the EPTA Meeting. The agenda of the EPTA meeting was informed to all the members via mail & telephonic calls on June 29, 2022.   - More Number of Tube Lights and Fans

  - School Building A & B- Painting
  - Water Proofing- Terrace and Building Exteriors of Building A & B
  - High Speed WIFI and Internet LAN Cable Connection in all the classes
