The orders regarding giving the permission/not giving the permission to the concerned institutes will be exited after receipt of your report only.

- 1. Concerned institute should be registered as per the Societies Registration Act, 1860 and the Bombay Public Trusts Act, 1950 or should be registered as per only the Bombay Public Trusts Act, 1950.
- 2. There should not be any serious complaints against the institute.
- 3. No recognition has been withdrawn of any of the school out of any primary / secondary school run by mentioned institute.
- 4. There have neither been any complaints regarding malpractice of any type in the concerned institute nor there is any case pending regarding taking possession of any of the schools run by the institute.
- 5. Financial condition of the institute is satisfactory.
- 6. The institute has made an application in the prescribed format with amended fees and there is no discrepancy in the name of the institute, place of school in the application.
- 7. The institute has paid penalty of Rs. 100/- for each academic year regarding keeping the school continued in spite of the non-approval of the Government.
- The institute will complete the fulfillment of the documents for the due approval of the Government within three months.
- The institute is required to charge fees as per the rate of educational fees prescribed by the Government in

The Competent Officers are required to submit their opinion only after actual inspection of the classes being conducted in the school and number of students in them while giving recognition to the concerned institutes and the permission will be granted on the basis of the same only.

12. The concerned school will not start the division of the medium other than that of permitted by the Government In this record. Government. In this regard as well, it is required to take a written guarantee letter on the stamp paper of Rs. 20/- from the concerned institute.

- 13. As per the provision in the Government Resolution No. SEN/2007/ (1001/2007) (3) SE-1, Date 19.10.2007, it will be binding for the it will be binding for the school to start within eighteen months, which has been given permission vide the Government resolution. The resolution should be submitted accordingly if it is to be started within 18 months by the institute. In case the school has not been started in year 2009-10 and it is not to be started in future, then the institute is required to produce a letter accordingly to this office along with its opinion.
- 14. It is required to take a guarantee letter from the institute on the stamped bond paper of Rs. 20/- of the Court mentioning that the institute is ready to run the primary school of English medium on the permanently nonaided basis and the institute will not demand any aid from the Government in future and its Xerox copies should be preserved on the file permanently.

15. The institute should give the information of the teachers appointed in the school along with it (e.g. Name, caste, date of birth, date of appointment, educational qualification).

16. Following matters should be fulfilled as per the order given on the date 14 April 2009 by the Supreme Court in the Public Litigation No. 483/04.

1. Fire fighting system should be installed within six months in the school.

2. Inflammable and dangerous items should not be kept in the building of the school.

3. Concerned staff and other employees of the school should be given necessary training in regard with the use of firefighting system.

4. It should be assured that the building of the school being safe in all perspective and also, the school has been constructed as per the standards prescribed under National Building Code of India before giving the recognition and it will be responsibility of the Education Officer (Primary) to issue such certificate.

5. Inspection of each school should be made in view of all the perspectives. Concerned officers should follow the National Building Code of India strictly. Disciplinary measures should be taken on the officials/employees who fail to carry out above jobs.



- 3. The school shall give admission to the weaker section and deprived group children in first standard and on the limits of 25% of the number of students and shall give free and compulsory education to them till their completion of primary

(eight) The teacher shall not engage himself/herself in private tuition/class, and the school precise the same.
