



The properties bearing house no 306 & 308 were purchased for the object of the trust, however is still in the possession of the owners Shri Chinubhai Shah & Others and the matter is in dispute & Legal steps are in process

**General Remarks .**

1. Separate boxes for Gold and Silver should be maintained and boxes should be maintained or numbered on the basis of receipt numbers issued for donation and valuation of the same should be carried out on quarterly or Financial Year basis.
2. The Valuation of Gold and Silver ornaments was last conducted on 21/10/2018 and the same has been incorporated in the financial year 2018-19. The same have also been considered as utilized for the objects of the trust, being ornaments for the deity. The donations of Ornaments received for the financial year 2018-19 is recorded on the basis of receipts issued for donation and Panchnama Report for articles out of donation box. The Purity of Gold and Silver Ornaments could not be ascertained as the same have not been valued by a professional valuer in the current financial year. Value of gold and silver has been taken as per rates prescribed by Income Tax Ready Reckoner and estimated reduction of 25% has been taken for ascertaining purity of gold articles and 40% for silver articles. During the financial year the quantitative details of gold & silver articles is as mentioned below -

Presently the values of the above articles have been accounted for on the above basis and the final values will be accounted on receipt of valuation reports from approved valuer

3. During the year the trust has taken quotations from various vendors before awarding the contracts for a major portion of the construction activity, however tenders have not been issued for the above contracts.
4. Incase of expenses for cattle feed, pooja expenses, local transport, etc., proper invoices are not available, however the amounts have been incorporated as per internal vouchers & records maintained by the trust. We have been informed that these invoices are not available as these items are bought daily from large number of local villagers.
5. With regard to School. Proper records relating to inward and outward of uniforms and Study Material is not maintained properly.
6. Amounts shown in the balance sheet as loans and advances to various trusts have been given during the earlier years.


