
## Whereas:

Pursuant to a Leave & License agreement dt: 25th April 2023 enter upon, use and occupy the premises being whole building of 9800 Sq.feet, Plus Basement of 2800 Sq.Ft and remaining open land of approx 3500 Sq.ft situated lying and being Survey no:18,9B, Plot No: 02 & 3, Village :Rahatni, Dist: Pune together with the right to use the common space and as more particularly described in the schedule hereunder written (premises) for a period 33 months commencing from 25th May 2023 to 31st May 2026 @ monthly1,58,500/- (One lakh fifty ) eight thousand five hundred only) each for the 11 months and Rs. 3,17,000/- (Rs. Three lakhs seventeen thousand only) for the next 22 months to be paid on or before 10th of every month.
