BHOR EDUCATION SOCIETY

Preamble.

Whereas after merger of Bhore State with the Province of Bombay, the citizens of Bhore, in a meeting held at Bhore, decided to establish a society for the purpose of undertaking the work of education, and whereas, the said meeting appointed a special committee of the citizens of Bhore to prepare a constitution for and establish such a society, to carry out the said purpose a society is established having the following constitution:-

Part I

General.

Name:- 1. The name of the society shall be "The Bhore Education Society."

Note:- The word "Society" shall hereafter mean "The Bhore Education Society."

Head Office:- 2. The head office of the society shall be at Bhore.

Aims and objects:- 3. The aims and objects of the society shall be:-

(a) To advance the cause of education by imparting education including primary, secondary, higher, commercial, technical among other kinds of education and to diffuse knowledge among the people of ~~the province of Bombay.~~ Maharashtra.

(b) Without derogation to the generality of the foregoing provisions, it shall be the particular aim and object of the society to take over the management of and conduct, the R.R. High School at Bhore.

4. For achieving and in furtherance of the above aims and objects the society can among other things,

(1) take over and conduct the management of the R.R. High School at Bhore.

(2) open educational institutions at Bhore and elsewhere.

(3) cooperate in the cause of education with other educational institutions.

(4) incorporate manage or affiliate institution under private management carrying on the above mentioned educational activities on conditions agreeable to parties concerned.

(5) make provision for funds to realise the object by accepting donations, borrowing money, accepting deposits, issuing debentures and loans on mortgage of the property of the society, or in any other manner which the governing council may deem fit.

(6) start loan funds and scholarship funds in order to help really poor and deserving students in prosecuting their studies.
