Sub.: Permission to establish and start a new school under The Maharashtra Self-financed Schools (Established and Regulation) Act, 2012. and allow to raise the standard of the existing school.

Ref.: 1. The Maharashtra Self-financed Schools (Established and Regulation) Act, (Gazette Extra ordinary No 24 of Government of Maharashtra) dated 2nd July 2013.
2. Government Resolution No SFS-1114/Pro No 40/SMZ/Mantralaya Mumbai 32, Dated 26 February 2014.

In respect of the above subject, you are informed that your organization had submitted a proposal to establish a new school/raise the standard of the existing school, from the academic year 2014-15 according to the provisions of The Maharashtra Self-financed Schools (Established and Regulation) Act, 2012. This proposal has been considered and as per the Government Resolution at reference No 2 cited above you are permitted to establish a new school/raise the standard of the existing school as per the following terms and conditions.

Terms and conditions:

1. The medium of instruction and the location of the school etc. as specified by the organization cannot be changed in future
2. The present permission shall stand null and void if the school is started at a place other than that given in the proposal.
3. The permission granted as per the provisions of this Act shall be from the academic year 2014-15.
4. The institute cannot start any more classes in addition to the classes for which permission is granted.
5. In case the proposed school is not started within 18 (Eighteen) months from the date of this permission, the permission shall automatically stand null and void.
6. It will be binding upon the schools so permitted, to follow all the Government directives issued from time to time, and also follow the provisions of the Right of Children to Free and Compulsory



Education Act or Right to Education Act (RTE) 2009 as also of The Maharashtra Self-financed Schools (Established and Regulation) Main Act, 2013.

7. It is binding on the institute to erect a display board – for the benefit of the public at large – in front of the façade stating that the School/classes is a self-financed school as per the provisions of the Maharashtra Self-financed Schools (Established and Regulation) Act, 2012.

8. The school once established under the provisions of The Maharashtra Self-financed Schools (Established and Regulation) Act, 2012, cannot be shifted to any other place in future.

9. The schools which are granted as per the provisions of The Maharashtra Self-financed Schools (Established and Regulation) Main Act, 2013 shall – after fulfilling the provisions of the Right of Children to Free and Compulsory Education Act or Right to Education Act (RTE) 2009 – file a "First Recognition Report" with the competent authority, as per the Secondary School code, Rule 3, Appendix 2.

10. The Managements / Institutes desirous of getting affiliated to the Boards like CBSE, ICSE, IGSE, and CIE etc. and permitted by the Government to do so as per the GR dated 20 June 2012 makes it mandatory for the schools to obtain the recognition. Such recognition shall be granted to the school, as per the paragraph (10) of the said GR, by the District Educational Officer (Primary), District Educational Officer (Secondary). Then the school shall apply for the necessary NOC, Along with the copy of the letter of recognition issued to them.

11. It shall be binding on the school recognized under the provisions of the Maharashtra Self-financed Schools (Established and Regulation) Act, 2012 to register itself separately as self-financed school / classes while entering the data in the U-DISE programme.

12. It shall be binding on the organization to follow the current Government Rules in force and any other Rules that will be enforced by the Government from time to time.
