INTRODUCTION

(1) The proposal of the School Billbong High International School S.N.169/170,Malwadi Road, Hadapsar, Tal.Haveli,Dist. Pune run by Lina Ashar Foundation Mumbai was submitted & the matter was under consideration to accord sanction to the said proposal.

GOVT.DECISION

(2,1) The Govt. hereby accord sanction to Billbong High International school, S.N.169/170 Malwadi Road, Hadapsar,Tal.Haveli,Dist.Pune run by Lina Ashok Foundation, Mumbai under Maharashtra Autonomous School (Establishment & Regulation) Rules 2012 (1 of 2013) for the year 2018-19 (From Primary to Higher Secondary, From Std.I to Std XII all faculties, English Medium (CBSE) subject to following terms & conditions.

2.2 TERMS & CONDITIONS:-

(1) The said Institution should submit the latest 7/12 extract of the land owned by the School admeasuring 500 sq. meters or copy of Sale-Deed or if it is a leased place, copy of Registered Lease Deed for 30 years (should be) submitted to the concerned Dy.Director Education within 3 months. If it is not complied with, the approval order issued to the School will stand to be canceled automatically. It is clearly mentioned in condition No.1 of the 2.2 conditions specified in Govt. The decision stated in reference No.3. The Education Officer (Primary) is authorized to see that the said condition is complied with & accordingly Education Officer





- (Primary) should get the compliance of it & submit the report to the Govt. within 3 months.
- (2) The School should comply with all the provisions of the Right of Children to Free & Compulsory Education, Rules 2009 & Rules./Provisions prescribed there under from time to time.
- (3) The following sanction (approval) is accorded for the year 2018-19 on compliance of all the provisions contained in Rules 2009.
- (A) If the School Management has all the prerequisites necessary for establishment of School as prescribed by the Government, then it should file an application for First Sanction with Education Officer of the concerned District within one month from the commencement of Academic Year.
- (B) IF the School Management is considered as eligible for the year 2018-19 vide the Government Decision and if it is not satisfying the norms and conditions prescribed by Govt.Rules, then it will be binding upon the School management to commence the School within 18 months from the date of Government Decision after ensuring the compliance of all the conditions, otherwise the permission granted will stand to be automatically cancelled.
- (C) The School will have to first obtain recognition for getting NOC for affiliation from CBSE Board as per inclusive policy prescribed in Government Decision dated 20/06/2012. After obtaining such recognition as per Paragraph (10) of Government Decision from District Education Officer (Primary)/District Education Officer (Secondary)/Education Inspector, B.M.C.C. the School will apply for N.O.C. from the concerned Board to the Government Authority. The Government will issue N.O.C. after processing such application & if the School is satisfying all the norms, conditions prescribed by Government, the Government will issue N.O.C. for affiliation to the Board.
- (4) The approved New School will have to abide by all the orders/procedures passed by Government and provisions of Maharashtra Autonomous School (Establishment & Regulations) Rules, 2012 (1 of 2013).





- (5) The concerned Competent Authority should ensure that provisions of Rules 2009 have been complied with & then only initiate further action in respect of according First Permission.
- (6) No change in medium, place of school etc will be allowed in future. If the School is run in the place other than the place approved by Government, the permission granted by Government will be canceled automatically.
- (7) It is the responsibility of the concerned Institution approved vide UDISE to get the School enrolled in the separate Category, "Approved School on Autonomous Basis" while filling up the information in Unified District Information system for Education. (UDISE). The State Project Director, Maharashtra Primary Education Council, Mumbai is hereby declared as Nodal Officer for further action in this matter. Similarly, the concerned School should display a board on the main entrance of the School stating "Approved School on Autonomous Basis(CBSE)" for the information of all concerned.
- (8) The recruitment of teaching & non teaching staff by approved Autonomous School should be done as per existing rules & policies of the Govt.
It is the responsibility of the Dy. Director of concerned Division to convey the said order to the concerned School within 15 days.

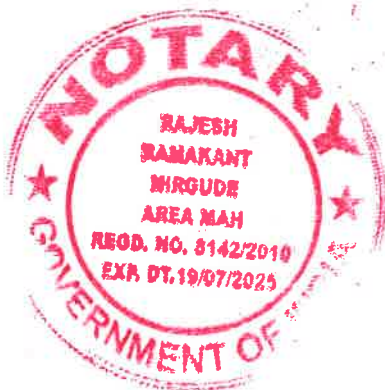

प्रस्तावना -

१. लिना आशर फाऊंडेशन, मुंबई संचलित बिलाबाँग हाय इंटरनॅशनल स्कुल, सर्व्हे.नं. १६९/१७०, माळवाडी रोड, हडपसर, ता.हवेली, जि. पुणे या शाळेचा प्रस्ताव शासनास सादर झाला होता. सदर शाळेस मान्यता देण्याची बाब शासनाच्या विचाराधीन होती.

शासननिर्णय-

२.१ महाराष्ट्र स्वयंअर्थसहाय्यित शाळा (स्थापना व विनियमन) अधिनियम, २०१२ (सन २०१३ चा ०१) अंतर्गत लिना आशर फाऊंडेशन, मुंबई संचलित बिलाबाँग हाय इंटरनॅशनल स्कुल, सर्व्हे नं. १६९/१७०, माळवाडी रोड, हडपसर, ता.हवेली, जि. पुणे ही नवीन शाळा (प्राथमिक ते उच्च माध्यमिक, इ. १ ली ते १२ वी, सर्व शाखा, इंग्रजी माध्यम, सी.बी.एस.ई.) सन २०१८-१९ या शैक्षणिक वर्षापासून खालील अटी व शर्तीची पूर्तता करण्याच्या अधीन राहून सुरु करण्यास शासन परवानगी देण्यात येत आहे.

२.२ अटी व शर्ती -

- (१) सदर संस्थेने शाळेच्या प्रस्तावित ठिकाणचा संस्थेच्या मालकीचा ५०० चौ.मी. एवढ्या जमिनीबाबतचा ७/१२ चा अद्ययावत उतारा किंवा खरेदीखत किंवा जागा भाडेकरारावर (लीज) असल्यास ३० वर्षे कालावधीच्या नोंदणीकृत भाडेकराराची प्रत संबंधित विभागीय शिक्षण उपसंचालक यांचेकडे तीन महिन्यांच्या आत सादर करणे आवश्यक आहे. या बाबीची पूर्तता न केल्यास सदर शाळेचे मान्यता आदेश आपोआपच रद्द समजण्यात येईल.
- (२) सदर शाळेने बालकांचा मोफत व सक्तीच्या शिक्षणाचा अधिकार अधिनियम, २००९मधील तरतुदींचा व या अंतर्गत वेळोवेळी विहित करण्यात येणा-या सर्व नियमांची/तरतुदींची पूर्तता करणे आवश्यक आहे.
- (३) शाळेच्या व्यवस्थापनाने अधिनियम, २००९मधील तरतुदींची पूर्तता करून सन २०१८-१९ या शैक्षणिक वर्षात शाळा सुरु करण्यास खालीलप्रमाणे परवानगी (इरादा पत्र) देण्यात येत आहे:-

अ) व्यवस्थापनाकडे शाळा स्थापन करण्यासाठी शासनाच्या विहित नियमानुसार आवश्यक असलेल्या सर्व बाबींची पूर्तता असल्यास शैक्षणिक वर्ष सुरु झाल्यापासून एक महिन्यांच्या आत प्रथम मान्यतेसाठी संबंधित जिल्ह्यांच्या शिक्षणाधिकाऱ्यांकडे व्यवस्थापनाने अर्ज करावा.


ब) व्यवस्थापनास सन २०१८-१९ करिता या शासन निर्णयाद्वारे पात्र ठरविण्यात आले असल्याने शाळा स्थापन करण्यासाठी शासनाच्या विहित नियमानुसार आवश्यक असलेल्या सर्व बाबी उपलब्ध नसतील तर त्यांना सदर बाबींची पूर्तता करून या शासन निर्णयाच्या दिनांकापासून अठरा महिन्यांच्या आत शाळा सुरु करणे बंधनकारक राहिल अन्यथा दिलेली परवानगी आपोआपच रद्दबातल ठरेल.



क) शासन निर्णय दि. २० जून, २०१२ मध्ये विहित केलेल्या सर्वकष धोरणानुसार सी.बी.एस.ई. मंडळाशी संलग्नतेकरिता ना-हरकत प्रमाणपत्र (N.O.C.) मिळविण्यासाठी प्रथमतः शाळेस मान्यता (Recognition) घेणे आवश्यक राहिल. शाळेने अशी मान्यता (Recognition) सदर शासन निर्णयातील परिच्छेद (१०) नुसार जिल्हा शिक्षणाधिकारी (प्राथमिक)/ जिल्हा शिक्षणाधिकारी (माध्यमिक) /शिक्षण निरीक्षक, बृहन्मुंबई यांचेकडून मिळाल्यानंतर मान्यता पत्रासह संस्था संबंधित मंडळाच्या संलग्नता ना-हरकत प्रमाणपत्र (N.O.C.) मिळविण्यासाठी शासनास अर्ज करेल. सदर अर्जाची छाननी करून सदर संबंधित शाळा विहित निकष, अटी व शर्तीची पूर्तता करित असल्यास शासन शाळेस मंडळ संलग्नतेसाठी ना-हरकत (N.O.C.) प्रमाणपत्र देईल.

- (४) परवानगी देण्यात आलेल्या नवीन शाळेस १) शासनाच्या वेळोवेळी निर्गमित होणा-या आदेशांचे व कार्यपध्दतीचे तसेच, २) महाराष्ट्र स्वयंअर्थसहाय्यित शाळा (स्थापना व विनियमन) अधिनियम, २०१२ (सन २०१३ चा ०१) मधील सर्व तरतुदींचे पालन करणे बंधनकारक राहिल
- (५) संबंधित सक्षम अधिका-यांनी अधिनियम, २००९ मधील तरतुदींची पूर्तता झाली असल्याची खात्री करावी व त्यानंतरच प्रथम मान्यता देण्याबाबतची पुढील कार्यवाही करावी.
- (६) संस्थेने शाळा परवानगीसाठी मागणी केलेले माध्यम, शाळेचे ठिकाण इत्यादी मध्ये भविष्यात कोणताही बदल करता येणार नाही. शासनाने ज्या ठिकाणी शाळा सुरु करण्यासाठी परवानगी दिलेली आहे त्या ठिकाणाव्यतिरिक्त अन्य ठिकाणी शाळा सुरु केल्यास शासनाने दिलेली परवानगी आपोआप रद्द समजण्यात येईल.
- (७) यु-डायस डाटा:- या शासन निर्णयाद्वारे परवानगी देण्यात आलेल्या नवीन शाळा / दर्जावाढशाळा बाबत जिल्हानिहाय U-DISE (Unified District Information System for Education) मध्ये माहिती भरताना, "स्वयंअर्थसहाय्यित तत्वावरील परवानगी प्राप्त शाळा" म्हणून स्वतंत्र प्रवर्गात नोंद करून यु-डायस क्रमांक प्राप्त करून घेण्याबाबतची जबाबदारी संबंधित संस्थेवर राहिल. याबाबतची पुढील कार्यवाही करण्यासाठी राज्य प्रकल्प संचालक, महाराष्ट्र प्राथमिक शिक्षण परिषद, मुंबई यांना नोडल अधिकारी म्हणून घोषित केले आहे. त्याचप्रमाणे, संस्थेने, सर्व संबंधितांच्या माहितीकरिता "स्वयंअर्थसहाय्यित तत्वावरील परवानगी प्राप्त नवीन शाळा/ दर्जावाढ परवानगी प्राप्त शाळा" असा जाहीर फलक शाळेच्या बाहेर प्रवेशद्वारावर लावणे आवश्यक राहिल.
- (८) परवानगी दिलेल्या स्वयंअर्थसहाय्यित शाळेमध्ये शिक्षक व शिक्षकेतर कर्मचारी यांची भरती शासनाच्या प्रचलित नियम व धोरणाप्रमाणे करावी.
३. सदर आदेश संबंधित संस्थेस १५ दिवसात कळविण्याची जबाबदारी संबंधित विभागीय शिक्षण उपसंचालक यांची राहिल.

Introduction

1. The Government had received a proposal from Bilabong High International School; survey No 160/70, Malwadi Hadapsar Road, Taluka Haveli, District Pune, managed by Leena Ashar Foundation, Mumbai and this matter was under consideration of the Government.

Government Resolution:

2.1 The Government hereby grants permission to Bilabong High International School; survey No 160/70, Malwadi Hadapsar Road, Taluka Haveli, District Pune, managed by Leena Ashar Foundation, Mumbai to start a new school starting from Primary level to Higher Secondary level (Standard 1 to Standard 12 all branches, English medium, CBSE pattern) from the academic year 2018-19 as per the provisions of the Maharashtra Self-financed Schools (Establishment and Regulation) 2012, under the Terms and Conditions set as under :-

2.2. Terms and Conditions:

1. The School authorities are required to submit the latest 7/12 extract of the land (where the school is proposed to be started) admeasuring about 500 sq. metres or copy of the sale-purchase deed, or if the land is taken on long lease then the copy of the registered lease deed executed in that regard, indicating the lease term as 30 years. These documents are to be submitted before the Deputy Divisional Director of Education within a period of three months. In case this requirement is not fulfilled then the order granting permission shall automatically become null and void.
2. The school authorities have to fulfill all the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the Rules and Provisions made thereunder from time to time.
3. The letter of intent is issued, as under, permitting the school authorities to commence the school from the academic year 2018-19 after due fulfillment of the provisions of the Right of Children to Free and Compulsory Education Act, 2009
 - a. In case the school authorities have the facilities prescribed by the government Rules (set for starting a school) ready with them, then the school management should apply to the first recognition to the concerned district education officer within 01 (one) moth from the start of the academic year.
 - b. Since the school management is considered to be suitable for starting a school in the year 2018-19 as per this decision, in case some facilities are not available, then the school authorities should create those facilities and start the school within 18 (eighteen) months from the date of this order, failing which this order shall automatically stand null and void.
 - c. Following the Universal policy set out in the Resolution dated 20 June 2012, before the school applies for affiliation with the CBSE Board, it has to have a No Objection

Certificate (NOC) and for that, the school shall have recognition, in the beginning. As mentioned in Para 10 of the said order, the school authorities have to obtain the recognition from the District Education Officer (Primary)/District Education officer (Secondary) / Educational Inspector Greater Mumbai, and once it is granted, then apply to the Government along with the letter of recognition thus awarded, to get the necessary NOC for CBSE Board affiliation. The Government shall scrutinize the said application and on confirming that the school authorities are fulfilling the norms, Terms and Conditions set in that regard, they shall issue the necessary NOC.

4. The school authorities that are allowed to start the new school shall follow (i) the Orders and procedures passed by the Government from time to time; (ii) all the provisions of the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012.

5. Before initiating the procedure of first recognition, the competent officer shall make certain of the provisions of the Right of Children to Free and Compulsory Education Act, 2009.

6. The school cannot change the location of the school and medium of instruction etc. in future under any circumstances. In case the school is started at a place other than the one for which permission is granted, the permission shall automatically stand null and void.

7. U-DISE Data: - The school authorities that are permitted to start a new school or up-gradation of the existing school shall furnish the data in the U-DISE (Unified District Information System for Education) system. The responsibility to register itself in a separate category as a "school permitted as per the self-financed school scheme" and obtain the necessary U-DISE number in that regard lies with the school authority. The State Project Director, Maharashtra Primary Education Council, Mumbai is declared to be the Nodal officer for further action in this regard. Moreover, the school authorities are required to display a board for the information of the general public, carrying the matter as - 'New School recognized under self-financed principle / school recognized for up-gradation'.

8. The appointment of the teaching staff and non-teaching staff shall be made following the existing policy and rules of the Government in that regard.

3. The concerned Divisional Deputy Director of Education shall be responsible for communicating this order to the school involved in this order within 15 days of this order.
