Permission to open new school
at the Kikavi during the year 1960-61-62

Sir,

Reference your letter No. NIL. of 1960-61 dated
6-6-1961 on the subject mentioned above.

2/- In view of the circumstances reported by you permission
is granted to open a Secondary school at KIKAVI Taluka
BHOR Dist. Poona teaching Std. VIII only through
Marathi medium on the following conditions with effect from
June 1960 1961

- 1) Adequate, suitable and well ventilated lighted accommodation is provided for the school. Similarly adequate sanitary arrangement are made.
- ii) Adequate furniture, teaching aids, Science equipment and that for Physical Education drawing etc. is provided
- iii) A sufficient play-ground is provided.
- iv) Teachers' and Pupils' libraries are furnished with adequate No. of books to start with.
- v) A trained graduate with at least five years' teaching experience is appointed as the Head Master and arrangements for the teaching of Science, Drawing, Hindi and Physical Education and other subjects are made by appointing suitably qualified and trained teachers of these subjects.
- vi) Fees are charged at the prescribed rates and if they are charged at higher or lower rates, permission of the Department is obtained for the same.
- vii) The Management undertakes to abide by the rules and regulations of the Department and to carry out the suggestions made by the Department from time to time.
- viii) The management should make arrangement to build up an adequate Reserve Fund within a period of three years.

3/- It should be noted that the question of recognition and grant to the school will be decided on merit when the school is actually started and inspected by the Department. The date of opening of the school and the arrangements actually made about accommodation, staff, furniture, library, the no. of pupils enrolled by standards etc. should be reported to this office immediately.

4/- The management is informed that no grant (even a token grant) will be paid to the school unless it is duly registered under the prescribed acts.

5/- Please acknowledge the receipt of this letter.

करावी लागत, याची कृपया नोंद घ्यावी.
