1. Welcome: -

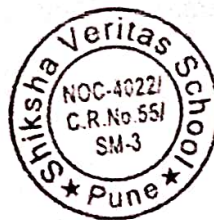
Mrs. Jayshree P. S, Chairperson of EPTA extended a warm welcome to all the members of the executive committee of EPTA 2021-22. She noted that the requisite quorum for the meeting was there and called the meeting.

2. Confirmation of last MOM held on 12-06-2021

Chairperson, Mrs. Jayshree P.S, read out the minutes of previous E-PTA meeting. The minutes were confirmed unanimously by the members by raising their hands.

3. To inform parents about fees for the Academic Year 2021-22

Chairperson, Mrs. Jayshree P.S, shared the approved fee structure for year 2021-22 with the E-PTA members.

All the members raised their hand and acknowledged the fee structure and the fee support provided to parents by the school.

4. To inform parents about revised fee for Academic year 2022-23 & 2023-24

Chairperson, Mrs. Jayshree P.S, stated that the last fee hike took place in 2019-2020 after that via an EPTA meeting held on 14th December 2019, the below fee structure was approved for next two academic years in accordance with the GR released by Govt of Maharashtra, dated 26th Aug 2019, Number - MAHENG/2009/35528. The GR specifies that the school can increase fee by 15% once in two years. The approved fee was also informed to all the parents within the stipulated time. The school has decided to not increase the fee structure every Two years rather it would do the partial revision every year ensuring it will not cross the threshold of 15% once in two years as prescribed by Govt. This was taken in to account so that the Parents would not have to bear high hike in fees every two years but rather it would increase gradually in line with school expense requirements.

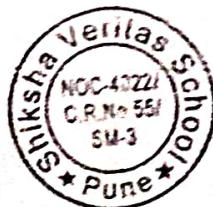
She further added that school has always been with parents by, understanding their problems, giving concessions in certain cases, giving extra time to them to pay the fee, and this gesture of not revising fee in spite of starting of physical school in 2021-22 shows our bonding with our parents.
Now we need to fix the fee structure for 2023-2024.

Mr. Dileep Gopalkrishnan, Management Representative told the parents that as per the fee regulation act the fee can be increased by 15% after every two years hence the next fee revision is due for the academic years 2023-24. In the year 2021-2022 the fees were kept the same and no hike was made similarly for year 2022-23 the fees was hiked only for first std and was kept same for other classes. He explained in detail to the members the Maharashtra Fee Regulation Act Norms 1A, 1B, 1C. Which states that -
As per Maharashtra Govt. fee regulation act - RNI no MAHENG/2009/35528 Dated 26th August 2019 Page no 3.

(1A) the management of private unaided schools and permanently unaided schools may choose to declare at the time of admission to the students, the standard-wise fee structure for all the standards i.e., from first standard to the tenth standard

OR

(1B) the management of private unaided schools and permanently unaided schools who does not choose to declare the fee structure as per the provisions under sub-section (1A) shall be



eligible to propose the fee in the school which shall not be more than previous academic year fee plus an amount of fifteen per cent. Of the said fee: Provided that, the private unaided schools and permanently unaided schools may increase the fee after two years from the date the fee approved by the Executive Committee

OR

(1C) The management of the school may increase the fee provided in the fee structure as mentioned in sub-section (1A) or propose the fee higher than the rate as provided in sub-section (1B) or before two years as provided in the proviso to sub-section (1B), in unforeseen events, with the approval of 76 percent. Of parents or approval of the Executive Committee by furnishing reasons or circumstances thereof"; He mentioned that we belong to the 1A and 1 B category. He further mentioned that at our school we provide the information of next ten years fee to the parents.

The Chairperson shared the proposed fee structure for the academic year 2023-2024. The approved fee structure is as follows

Fee Fixation Proposed Fee for the academic year 2023-24 as per the GR released by Govt of Maharashtra on 26th Aug 2019, number MAHENG/2009/35528 the school can increase fee by 15%. Due to Covid the fess structures were not hiked though the rentals and salaries have been hiked, the school could have increased the fees by 30% for the year 2023-24 as per 15% every 2 years. The school has decided to hike the fees by 9% to 20% for various classes as the fees has not been increased from last four years for year 2023-24.

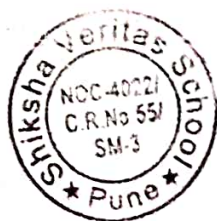

Chairperson Mrs. Jayshree P. S and Management Representative Mr, Dileep Gopalkrishnan P.S requested all the parents to give their consent regarding the above proposed fee structure for the academic year 2023-2024 by raising their hands.

All the members raised their hands and unanimously agreed to the proposed fee structure for the academic year 2021-2022 and 2022-2023.

5. To inform parents about Uniform colour and pattern change for AY 23-24:

Chairperson Mrs. Jayshree P. S informed parents about the proposal to change the School Uniform and its pattern as it had been the same from the time of the inception of the school.



The Sports uniform pattern was also discussed to be changed as it was also the same from inception and also new design patterns could be introduced as per the availability. Parent Mr. Kimmatkar observed that last year during covid times the Uniform and bags supplied by the vendors were not up to the mark, It was suggested by the Mr. Kimmatkar that all vendors also need to be changed.

The Chairperson assured them that all vendors will be replaced. All the members raised their hands and unanimously agreed to the proposed Uniform change for the academic year 2023-2024.

6. To appeal parents to pay prescribed fees regularly:

The Chairperson Mrs. Jayshree Dileep P.S requested the parents to pay the fees timely so as to maintain the infrastructure and salaries and other day to day functioning of the school is not hampered. Many parents who have refused to pay even after multiple reminders and extensions were to be stopped from using the school online portal as the charges for portal also were incurred due to the same. The parents unanimously agreed for the same as the services would have to be discontinued for nonpayment by major parents.

7. Annual report of school Presentation:

Mrs. Seema Shetty, teacher's representative presented the school Annual report for 2020-21. She said that it was a very tough year due to pandemic in all aspects.

The teachers and Parents were trained to use the online portal through different meetings. They were informed about the chapter wise recorded content available online, if they miss the class.

School Enrollments-

There were 320 students enrolled for year 2021-22. Last year the strength was 300 nos. But we are still far from the pre academic strength of 380 children. Due to pandemic many parents migrated to their native places and most of parents could not afford school fees though school gave discount in fees. Overall pandemic affected the new admissions in this year too.

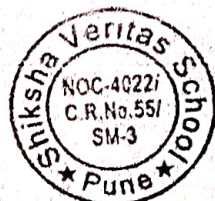
Academic Activities:

Competitions and academic activities that go beyond the text books and the classrooms encourage and foster a healthy and competitive spirit and effective communication skills in the students. The activities were conducted Online at classroom level, school level and inter-house level. Some of these events were handwriting, essay, speech and slogan writing competitions. Competitions are also held for Poetry recitation, story writing and narration, debate, English and Hindi elocution, GK, IQ and Maths quiz competitions.

Science, Maths and English Olympiad are conducted every year and the students perform excellently at the local as well as National level.

Reading Day was made memorable by arranging online reading session. In each class students brought their own books and the aim was to encourage and inculcate the habit of reading.

The school had its own Veritas times magazine which has articles written by students of classes 5,6,7,8. There was riddles and stories written by students of class 4.



Through the school, students are encouraged to subscribe to magazines like Teenager, inspirational quote, Vayam magazine etc.

Art Integrated learning has been a hallmark of the school; being compulsory activity. An elaborate Art Exhibition is conducted every year which draws a lot of attractions and students willingly contribute to its success. This year it was online school so students had Art exhibition online and parents purchased the piece of art made by students and collected it from school. Our office was working throughout year during 2021-22 session.

Yearly Celebrations:

To foster national integration, international understanding, religious and cultural awareness and tolerance, various national, religious and cultural festivals and occasions were celebrated online throughout year like.

***National Festivals:** Independence Day on 15th August 2021, Republic Day 26th January 2021, and Kargil Vijay Divas on 26th July 2021 were celebrated with due reverence for our motherland with patriotic songs and dances. Students perform the act enthusiastically though it was online celebration but students gave their best.

***School Celebrations:** Students had exposure of online Sports day on 11th December 2021 and will also celebrate the Annual day on 5th March 2021.

***Religious Festivals:** All religious festivals like Ramzan Eid, Muharram, Diwali, Ganeshotsav, Parsi New Year, Buddha Purnima, Easter, Guru Nanak Jayanti etc were celebrated throughout the year with due respect to the religious sentiments of our students. All these events were celebrated online this year.

***Other Celebrations:** The school gives due recognition to significant global events and celebrate these days. Some of these events are International Women's Day, International Workers Day, Hindi Divas, Yoga Day, Onam, World Peace Day, World Hunger Day, Shivaji Jayanti, Road Safety Day, Save our Planet Day, Girl Child Day etc. All these events were celebrated online enthusiastically.

Students Behavior and Discipline –

Due to Online school students became lazy to follow all discipline though they were instructed to follow routine of physical school. Students were at home and due to online schooling; they had option to hide their face. It was difficult for teachers to find whether students are really attending classes. Teachers had a meeting with parents and informed them to cooperate by monitoring students during online classes. Students had developed the habit of playing online game during this period so teachers had concern about the same.

We observed that even in online schooling students were completing all assigned work and they really progressed well. Teachers conducted assembly online and there was group meditation session every day after assembly which helped students to improve their concentration during this difficult situation.

Mrs. Sarah Teacher took responsibility to conduct moral sessions twice a week apart from regular online classes so that students will not lose interest of academics and it will help students to keep their moral boosted during pandemic situation.



Teaching staff-

All teachers were experienced and highly qualified. Our teachers are committed in providing a high-quality education for all students and they received ongoing professional development to stay current with best practices and research-based strategies. Training for Online classes was provided to them. They gained technical knowledge about using available online class support systems. There were 15 teachers during online teaching who gave their best in teaching.

Mrs Seema then asked the Chairperson to talk about the future plans and Initiatives-

The Chairperson said, as we look to the future, we are committed in providing a high-quality education for all students and preparing them for success in the 21st century. Our plans for the coming year include expansion of classrooms, adding more teaching aids in Mathematics labs and Language labs. We have plan to start Abacus class for classes 1 to 6. This is brain development program which will improve students in their concentration, speed and accuracy. It will help students to perform well in all kind of activities including academics. We are planning to start this program as a part of curriculum from next session.

We are planning to start Vedic mathematics class for classes 6 to 8. This is very interesting program which will help students to learn lot of easy methods and tricks to solve multiple steps sums. Vedic mathematics was introduced by Bharati Krishna Tirthaji and according to his theory, whole mathematics concepts are based on 16 Sutras and 13 sub-sutras. This will help students to get rid of the fear of mathematics. They will gain confidence to solve big sums. We are planning to start this program as a part of curriculum from next session.

We also have a plan to build Art and craft rooms, where students will learn creative work. It will also help students to develop their imagination skill, creative skills. Students 3 dimensional concepts will be also cleared with the help of this activity.

She Concluded by thanking the entire team, management and parents for cooperating and supporting us during Covid.

8. **Any other points:** Mrs.Chandak parent expressed her willingness to talk and was thankful to all teachers who took online classes during Lockdown and said that the teachers made sure the children never missed their classes.

Mrs.Adigantla parent expressed her opinion that the teachers insist on children to keep their cameras on as some kids were not focusing on studies while the teachers were teaching and were disturbing the classes

Both the points were noted and the chairperson said necessary steps for the same will be taken.

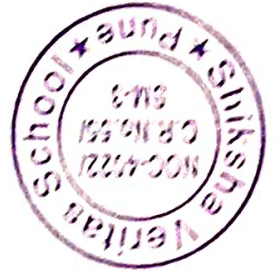

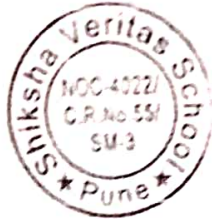
