independent Girls & Boy's Schools...

Sir,

Reference your letter No.6081/70-71 of 11-3-1971
on the subject mentioned above.

2. Under instructions from the Dy.D.E.P.R.Poona-5
I have the honour to inform you that the Sadhana Vidyalaya
Hadapsar are allowed to bifurcate the present mixed
school into two independent units i.e. one for Boys and
one for girls with effect from June., 1971 on usual
terms and conditions and on the following conditions.

1. The condition of average attendance in
respect of girls school will not be relaxed, if there
is no sufficient No. of girls on the roll.

2. Additional clerical staff should not be
appointed at present. The present staff should be
bifurcated according to the need of the schools.

3. Additional expenditure on furniture,
equipment, books etc. should not be made immediately
being bifurcation of the mixed school into independent
units.

4. Lady teachers should be appointed on the staff
of the girls' school. A qualified and experienced lady
teacher should be appointed as Head of the Girls
School.

5. Girls should not be admitted into the boys
school after its bifurcation.

The bifurcated girls school should be treated
as an old school for grant-in-aid purposes and grants
shall be released accordingly.

Please refer to your letter No. Edn/Sec dated
22-3-1971 on the above subject.

In view of your recommendations the school
authorities of the Sadhana Vidyalaya, Hadapsar are
allowed to bifurcate the present mixed school into
two independent units i.e. one for Boys and one for
girls with effect from June, 1971 on usual terms and
conditions and on the following conditions.

1. The condition of average attendance in
respect of girls school will not be relaxed, if there
is no sufficient No. of girls on the roll.

2. Additional clerical staff should not be
appointed at present. The present staff should be
bifurcated according to the need of the schools.

3. Additional expenditure on furniture,
equipment, books etc. should not be made immediately before
bifurcation of the mixed school into independent units.

4/- Lady teachers should be appointed on the
staff of the girls' school. A qualified and experienced
lady teacher should be appointed as Head of the Girls
School.

5. Girls should not be admitted into the
boys school after its bifurcation.

The bifurcated girls ~~school~~ school should
be treated as an old school for ~~the~~ grant-in-aid
purposes and grants should be released accordingly.
