Subject: Fees Revision

BCA & Jr. College run by WIL is a permanently unaided English Medium School. We charge fees to the students and revise them time to time to meet the expenditure incurred on employees' salary, infrastructural developments, facilities etc. Viewing salary increments of employees, requirement of additional facilities and infrastructure due to substantial increase in students' strength, we had revised school fees from the academic year 2020-21 with Resolution No.7 of EPTA meeting dated 07.03.2020.

- 1. In case of outsider wards, we revise school fees after every TWO years as resolved in PTA. We had revised school fees for outsider wards @20% rise for 2020-21 & 2021-22.
- 2. In case of WIL wards, Fees was revised while maintaining 50% concession to the outsider rate after TWO years 2020-21 & 2021-22.
- 3. Simultaneously we had revised School fees for SWV/PRI/WSB wards while maintaining 25% concession to the outsider rate.
- 4. It was resolved to revise fees of <u>BCA wards to avail only 75%</u> concession to the outsider rate.
- As per practice, WIL Management compensates the Fees deficit caused by the fees concession, rendered to the WIL / SWV / PRI / BCA wards.
- It was further resolved to continue the present provision of late fees for the late payers who will pay school fees after 31st July with revised rate.
- 7. Further to this, it was resolved that fees of CRTM, SMS (arranged for better education and communication through Students' Store) will be collected with Annual fees in case of outsider, SWV. PRI, WSB wards & separate receipt will be generated for the same through Students' Store. In case of WIL & BCA Wards these fees will be recovered from Salary in 03 installments.
- 8. The fees was revised for 02 academic years 2020-21 and 2021-22

Financial Decisions during Corona pandemic

Due to outbreak of Covid – 19 Pandemic, it was resolved in EPTA meeting dated 14.06.2020 by resolution No. 04 that the revised approved fees by resolution no. 07 dated 07.03.2020 will not be charged for academic year 2020-2021 viewing changed socio economic situations. It was further resolved that the fee structure approved by PTA in the meeting dated 07.03.2020 will be implemented from academic year 2021-22 and without further discussion or approval.

In this way, School Management rendered 20% concession in School Fees to provide financial relief to the parents. Along with this, School Management also suspended provision of late fees for academic year 2020-2021 and allowed parents to pay up fees in 02 installments. Further to it, School Management waived off CRTM, SMS Fees for 2020-21 and provided additional facilities like learning apps (Top School and Top Scorer) free of cost to the students to facilitate learning during corona lockdown.

When Covid 19 severely affected all socio economic activities in 2020 and 2021, it was resolved in EPTA meeting dated <u>23.07.2021</u> by resolution No. 04 and PTMs conducted on <u>07.08.2021</u>, <u>09.08.2021</u>, <u>10.08.2021</u>, <u>11.08.2021</u>, <u>13.08.2021</u>, <u>14.08.2021</u> that the revised approved fees by resolution no. 07 dated <u>07.03.2020</u> will not be charged for academic year 2021-2022 too viewing troubled financial conditions of the parents. It was further resolved that the fee structure approved by PTA in the meeting dated <u>07.03.2020</u>, provision of late fees, CRTM and SMS fees will be implemented from academic year 2022-23 without further discussion or approval.

In this way, School Management rendered 20% concession in School Fees to provide financial relief to the parents. Along with this, School Management also suspended provision of late fees for academic year 2021-2022 and allowed parents to pay up fees in 02 instalments. Further to it, School Management waived off CRTM, SMS Fees for 2021-22 and provided additional facilities like learning apps (Top School and Top Scorer) free of cost to the students to facilitate learning during corona lockdown.

Resolution No. 7

As referred above, School Management has tolerated heavy financial burden during academic year 2020-21 and 2021-22 but stood with parents and students in difficult time of corona and continued teaching-learning process uninterruptedly with strong support of BCA Staff.

Herewith, we propose to implement revised fees structure as resolved in the resolution No 7 of EPTA meeting dated 07.03.2020, resolution No. 4 in EPTA meeting dated 14.06.2020, resolution No. 4 of EPTA meeting dated 23.07.2021 and PTMs dated 07.08.2021, 09.08.2021, 10.08.2021, 11.08.2021, 13.08.2021, 14.08.2021 17.08.2021.

 In case of outsider wards, we revise school fees after every TWO years as resolved in PTA. But, now we propose to revise school fees for outsider wards @20% rise for 2022-23 & 2023-24 after 04 years (From 2018 to 2022) which will sum up to Avg Rs. 3308/- PA and Rs. 276/- PM only.

- In case of WIL wards, the school fees will be revised by granting 50% concession to the outsider rate for 2022-23 & 2023-24 after 04 years (From 2018 to 2022) which will sum up to Avg Rs. 1985/- PA and Rs. 165/- PM only.
- In case of SWV/PRI/WSB wards, the school fees will be revised by granting 25% concession to the outsider rate for 2022-23 & 2023-24 after 04 years (From 2018 to 2022) which will sum up to Avg Rs. 2481/- PA and Rs. 207/-PM only.
- 4. In case of <u>BCA wards</u> the school fees will be revised and restructured by granting 75% concession to the outsider rate for 2022-23 & 2023-24 after 04 years (From 2018 to 2022) which will sum up to Avg Rs. 1963/- PA and Rs. 164/- PM only.
- As per practice, the fees deficit caused by concession rendered to the WIL/ SWV / PRI / BCA Wards will be compensated by WIL Management.
- 6. We also propose to resume provision of late fees for the late payers who will pay School fees after 31st July with revised rate.
- 7. Further to this, in case of outsider, SWV, PRI, WSB wards propose to collect fees charged by Students' Store for CRTM, SMS facilities (Arranged for better education and communication) with annual fees. A separate receipt will be generated for this through Students' Store. In case of WIL and BCA wards deducted through salary dedication in 03 instalments.

This fees will be effective for next 02 academic years of 2022-23 and 2023-24.
