- 1) The school presented last year budget summary and explained the rationale for calculation of fees for the coming year 2023-24, within the framework of fee fixation norms.

- 2) The school Board and core committee after exploring various options presented the proposal for the next year fees

The fees proposal for the year 2023-24 was given as follows

Proposal -

- 10% hike on annual fees for classes I to IX
- 50% fees for new admission has to be paid at the time of admission and rest after Diwali.
- Old parents has to be paid in two installment.

Parents had queries based on the fee presentation and discussion which were duly addressed and answered by the school heads.


EPTA ratification on fee proposal.
