EPTA requested the school if portion could be completed one week before exams. Principal & Teachers felt it is not possible to complete it one week before revision test.

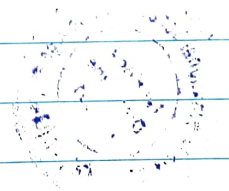

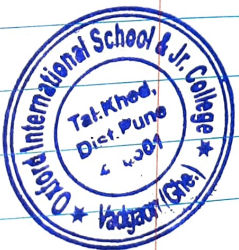

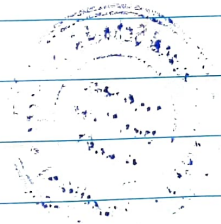
