2) The Management should please be got registered as required under the relevant rules in the matter.

3. It should please be noted that the question of recognition and grant to the school will be decided on merit when the school is actually started and inspected by the Parishad Education Officer, Zilla Parishad, Poona, within one month or so, of the opening of the school. The date of opening of the school, the arrangements actually made in respect of accommodation, staff, furniture, library, the No. of pupils enrolled in each

each Standard etc. should please be reported to this office and the Parishad Education Officer, Zilla Parishad, Poona.
