The meeting was conducted in the online mode via the Zoom app.

In presence of Managing Trustee Mr. Fatehali Patel and Vice Principal Mrs. Saher Khan

The meeting commenced with a warm welcome to the PTA members extended by the Principal, Dr. Mrs. Roshan F. Patel. The proceedings of the meeting began when Mrs. Saher Khan, who read the minutes of the previous PTA meeting, and was approved by all present.

Mrs. Saher Khan read and discussed the Agenda of the current PTA Meeting. The following points were discussed in the meeting:

1) Admissions for the Academic Year 2022-23:

It was disclosed to the PTA meet that the admissions forms for the Academic year 2022-23 are now available at the school office and the PTA members were asked to spread a word across their respective groups so that the parents are aware and can avail the opportunity at their earliest.

It was informed that the forms were made available at the office from Wednesday, 15th of December, 2021.

2) The Fee Defaulter List:

It was mentioned before the PTA meet that the list of the fee defaulters is growing long day by day. According to the law, if a cheque gets bounced, it becomes a punishable offense. Mr. Patel added that such incidents create a negative impact on the reputation of the school accounts maintained in the bank as the bouncing of cheques is featured in the transactions and may turn out to be a barrier while considering the goodwill of the school account.

Apart from the corporate rules, parents should understand that the fees are paid for the education of their child and they should maintain the sanctity of the situation. These are not the values to be passed on to the next generation.

The management put forth a suggestion that a heavy penalty should be charged in such cases. The parents were requested to approach the management and give a written confirmation regarding the deadline date for the payment of fees in case they face a financial crunch. If the cheques are bounced even the management has to pay the penalty. Parents should comprehend such situations and be ready to bear the loss imposed on the school account because of their misdemeanour. Rupees 1000/- was accepted as the penalty to be charged in case the cheques are bounced. The money would be utilized for the benefit of children.

ICSE and HSC Board Exams:

Principal, Dr. Mrs. Roshan Patel, mentioned that the dates for the Semester II ICSE board exams will be announced officially on the website. Parents were requested not to rely on rumors. Same was the case with the HSC board exams.
