

Second PTA Working Committee meeting  
Date - 16<sup>th</sup> September 2017  
venue - VPSEMS.



The second PTA working committee meeting was held on 16<sup>th</sup> September 2017, Saturday at 12-15 pm in VP's Someshwar English medium school. The committee deliberated, discussed and resolved on the following issues.

subject 1 To read the minutes of previous PTA meeting.

Resolution 1 Minutes of previous PTA meeting were read. Review was taken by the committee to see the action taken on the issues discussed during previous meeting.

subject 2 To discuss about I Semester exam.

Resolution 2 The principal explained that I semester exam will start from 5<sup>th</sup> October 2017 as planned in the school calendar. It will end on 14<sup>th</sup> October 2017. Oral and practical exams will be conducted after diwali vacation. This decision is taken to get enough time to complete syllabus and to take proper revision.

It was also told that format of the question paper and sample question papers for the I semester will be uploaded on school website as well as they will be available in Sankalp Book Shoppe for the parents.

subject 3 To discuss about Robotics and Power English courses.

Resolution 3 The President of PTA explained the need of Robotics and Power English classes and need of implementing them in the school.

subject 4 To discuss about PTA picnic

Resolution 4 It was discussed that this is the second year of this PTA working committee and we should have one day picnic. The Principal asked one of the PTA working committee members to take an initiative and arranged one day picnic for all the PTA members possibly on a holiday so the teaching and learning don't get disturbed.

subject 5 To discuss about fee hike from academic year 2018-19.

Resolution 5 The school fee hike was done in the academic year 2015-16 and as promised to the PTA it was not increased for the last three years. The Principal expressed the need to increase the school fees with RS 6000/- for year to meet the needs of the school from std nursery to std X. The members of PTA discussed on this issue and agreed to increase the school

fees with Rs 4000/- from the academic year 2018-19. Resolution for the fee hike was also signed by the members of PTA. The Principal assured the parents that the school fees will not be increased for the next two years.

The Principal told the PTA members that this new fee structure will be displayed on the notice board after the permission of Hon. Executive committee of V.P. Any objection on this to be discussed by or before 30 December 2017 with the Principal of the school.

subject 6 Any other subject with the permission of the chairman.

Resolutions During general discussion following issues were discussed.

Res - 6.1) Parent representative of Class III B complained about (Mrs. Leena Panaware) It is about her way of <sup>of her</sup> <sup>teacher</sup> pronounciation and the way of talking with the students.

→ The Principal promised that there will be proper action after confirming the complaint.

② Parents demanded that teachers should not be changed in between.

Res-62 → Principal explained that if teachers resign from the job we can not reject it if they come through proper channel

Teachers who have left, it is only because of their personal reasons. In such situation we can not ask them to continue.

But sir also promised that school will take proper care so that there will not be academic loss of the students.

③ Parents requested that students notebooks should be checked properly.

Res-63 → Principal sir told that no doubt notebooks checking must be done properly and on time he told it will be implemented.

④ There is complaint from std & PTA

Res-64 representative that students are unable to complete black board writing in a particular period. Thus most of the time their notebooks are blank.

Res-64 → The Principal told that all the teachers will be instructed for the same. They will take proper care about the same.

⑤ PTA member of std I told that question papers must be error free.  
 Res-6.5 → The Principal agreed that question papers must be error free. He told that it will be told to the respective teachers, Hop's that proper care must be taken while drafting the paper.

⑥ Some parents asked is it possible to complete the syllabus in time at the end of the year.  
 Res-6.6 → The Principal told that probably we are going to reduce diwali vacation as well as christmas holidays to give more practice to the students.

⑦ PTA member of std ix told that students should get new format of exam pattern.  
 Res. 6.7 → The Principal explained that all the teachers have attended the training programme for new syllabus of std ix. and they will give all information to the students very soon.
