Dear Sirs,

1) One set of modifications to previous plans received from you vide letter no. cited above is hereby approved and returned to you subjected to following conditions.

2) You had submitted plans & drawings for 681.64 sqm. plinth area and 1545.41 sqm. total built area on the plot having area 103685.00 sqm. & at present this office has approved plans for 1545.41 sqm. total buildup area submitted by you. This office has approved only 3 SETS of drawing, details of which are attached in the accompanied statement.

a) In case of approval to the modified plans the original approval to the drawings granted vide this office letter no. TB/BMT/PLAN/ dated from this office of the Executive Engineer, MIDC Baramati Division is treated as cancelled as the drawings now supersede the previously approved drawings. You are requested to return the previous drawings to this office for record and cancellation.

b) In case the drawing now approved are for additional structures which are not approved previously, the present approval & the previous approval under letter No. TB/BMT/PLAN/2667 dt.07/09/95 from the office of the Executive Engineer, MIDC, Baramati division, Baramati - 413133 are to be treated as combined approval for building for the said plot.

3) This approval is given subjected to the approval from following authorities.

i) Local town planning Authority/Municipal authority/Collector District.

ii) Department of Explosive of Government of Maharashtra.

iv) P.W.D. or concerned authorities, in case of plot facing to National Highway.

You should submit the certified copies of the approval in triplicate from the above authorities to Executive Engineer before any work is started.

4) For the sanitary block overhead water storage tank of 450 litres/W.C./urinal shall be provided.

5) Necessary approach road to the plot from the edge of MIDC road shall be provided with a cross drainage of pipes of minimum 450 mm dia or higher size pipe or slab drain as may be approved by the Executive Engineer.

6) Temporary structures shall not be constructed during construction period. (If required prior approval from the Executive Engineer shall be obtained and shall be demolished immediately within one month from completion before occupation of approved construction).

7) During construction period, stacking of the construction materials shall be done only in the area of plot allotted to you. In no case material shall be stacked along MIDC's land, road, open plot area without prior approval from the Executive Engineer.

8) The boundary marks demarcating the boundary of plot shall be properly preserved and kept in good conditions and shown to the departmental staff as and when required.

9) No tube-well, bore-well or open well be constructed by the plot holder without prior permission in writing.

10) The work of water supply and drainage pipelines shall be carried out through licenced plumber only as per water supply regulations of MIDC. Separate approval for drainage and water supply connection is to be obtained from the Executive Engineer prior to construction.

11) Plans for any future additions, alterations and extensions will have to be got approved from this office as well as departments competent to do so prior to construction.

12) The present approval to the plans, does not pertain to approval to the structural designs and RCC designs, foundation etc. It is only locational approval to the structures with reference to the plot.

13) In case of any power lines, passing through the plot, plot holder should approach to the M.S.E.B. authorities to obtain the letter specifying the vertical and horizontal clearance to be left and shall design the structures accordingly.

14) Wherever a compound wall and gate is to be constructed, the gate should open inside the plot. If plot is facing to two or more sides of the roads, then gate shall be located at least 15 mtrs. from the corner of plot at junction of roads.

15) The waste effluent from the treatment work should be soaked in soak pit if sewer lines are not available in the area. If sewage system of MIDC is functioning, effluent line should be connected to drainage manhole after getting approval to drawing. Storm water flow from rain water pipe shall not be connected to MIDC's sewerage system. Further any waste effluent to be let out in MIDC's sewerage system, it shall be retreated to the standards laid by Maharashtra Pollution Control Board of Maharashtra Government after obtaining their consent under section 28 of the act.

16) Plot holder should make his own arrangements for 24 hrs. storage of water by constructing an underground water storage tank of required capacity as uninterrupted water supply can not be guaranteed by the department.

17) In case the way of natural water streams are passing through the plot allotted, the plot holder has to ensure that minimum quantity of rain water that flows at the point of entry of streams is allowed to flow uninterrupted through the plot and maintain the point of flow of the original or diverted streams. The detailed discharge of rain water through the plot has to be furnished to this office and no work of plot levelling or diversion of nullas shall be undertaken without written permission from the Executive Engineer.

18) This permission stands cancelled, if the construction work is not started within 12 months from the date of issue of this letter. The date of starting of construction work and date of completion should be informed to the Executive Engineer or Area incharge immediately.

19) The breach of any of above stipulations shall render the plot holder liable for action as provided in MIDC Act-1961 (III of 1961) and regulations made there under and also as per terms of lease for schedule of penalties prescribed by the Corporation for the purpose.

20) The competent authority of the department has got power to add or amend, to vary or rescind any provision of regulations from time to time as it may deem fit, and plot holder has to abide such rules and regulations.

21) As soon as the building work is completed the plot holder should approach the Executive Engineer, MIDC Baramati Division, and get the work verified. The buildings should not be occupied, unless completion certificate is obtained, from the Executive Engineer in prescribed form.

22) This approval is subjected to permission of competent authority under land ceiling and regulation Act. 1976.

23) PLANTING OF TREES IN THE OPEN SPACES :-


a) The plot holder shall hit own expences (within a period of one year from the date of possession) to plant the trees in the open spaces on the periphery of the said plot (One tree of 20 sqm.) and shall maintain the trees in good conditions.

24) The plot holder should invite the Executive Engineer/Deputy Engineer, to check up the plinth of the building, when the plinth level is completed and obtained plinth checking certificate from Executive Engineer, without which no further construction above plinth shall be permitted.

You are requested to go carefully through the conditions of this letter and take necessary action accordingly. Please acknowledge the receipt of this letter and please approach to M.S.E.B. authorities for Power connection.


