

Sir,

As per Govt. orders Std. V-VII are being progressively attached to Non-Govt. Secondary Schools and correspondingly these standards in primary schools located in the respective areas, are to be closed down. This office has directed some Headmasters of primary schools located in your area to close down their Stds. V-VII and transfer their students to your secondary schools. This does not, however, mean that any additional divisions of Std. V-VII will be allowed to be opened in your school from June 1979. The intention of giving these orders to the Headmasters of primary schools is that there should not be any idle capacity remaining in Std. V-VII of primary schools and you should be able to admit maximum number of students that are to be admitted as per S.S. Code Rules.


2/- In the circumstances you are, hereby requested to admit only the maximum number of students in the sanctioned divisions of your Std. V-VII only. Please also note that no additional division of Std. V-VII will be allowed to be opened in your school from June 1979. If you have any doubts or difficulties in this respect you may please write to me by a D.O. letter.




