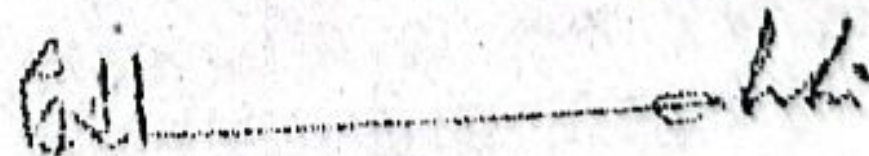

Sir,

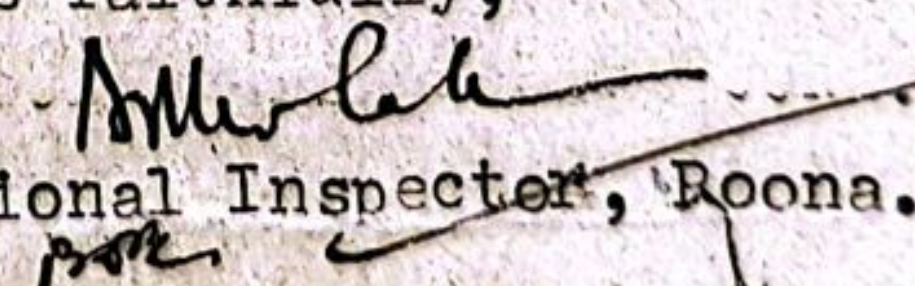
I have the honour to send herewith the Inspection Report for the year 1954-55 and to inform you that your school has been recognised as a secondary school teaching Stds. VIII and IX for the year 1954-55 and the same has been provisionally continued for the year 1955-56 subject to the fulfilment of the following conditions and conditions laid down in the Inspection Report by May, 1955 without fail.

- 1) The Headmaster should be a trained graduate preferably a B.Sc. B.T.
- 2) Services of D.T.C. should be secured.
- 3) Adequate science apparatus and other ~~school~~ equipment such as charts, pictures, maps etc. should be secured.
- 4) Govt. Provident Fund Scheme should be retrospectively introduced.
- 5) Provisions of Grant-~~in~~ aid code should be strictly observed.
- 6) School should be kept open to all the pupils irrespective of caste and creed.
- 7) A reserve fund of at least Rs. 3000/- should be deposited in the bank.

2/- A detailed report regarding the fulfilment of the above conditions should be submitted to this office by 1st June, 1955 at the latest.
