In addition, the management has also decided to waive off the activity charges and lab fee for academic session 2021-22 for online classes. The fee structure is attached along with these minutes as Annexures I to III. The PTA members appreciated and applauded the decision of school. The school did not hike the 15% fees to compensate activity charges & lab fee collected for academic session 2020-21.
