I have the honour to inform you that your application in the prescribed form received in this office for recognition by this Board, under Regulation 19(1) and the recommendations thereon from the Education Officer/Educational Inspector and the Dy. Director of Education concerned were considered by the appropriate authorities of this Board along with the Inspection Report of your school; and I am directed to inform you that your school is provisionally recognised for the current academic year i.e. 1967-68 for the purposes of admission to the privileges of this Board, subject to the fulfilment of the conditions laid down by the Education Officer/Educational Inspector concerned as a result of his last inspection and also subject to the following further conditions. Conditions to be satisfied

- ✓ 1) For 1967-68 the school is recognised for the subject "Gen.Science" only as a special case and not for Phy.Chemistry as there is no trained science graduate on the staff of the school.
- ✓ 2) Next year, the school will not be allowed to teach Phy.Chemistry unless a trained science graduate is appointed in June 1968 and the report of having done so is made to this office by the end of June 1968.
- ~~3) The proportion of part-time Teachers is excessive. More graduate teachers should be appointed; atleast equal to the number of divisions maintained by the school.~~
- ~~4) The present Head Master possesses 1) No adequate professional qualifications and 2) No adequate teaching experience. The deficiencies should be removed and report made to this office.~~
- 5) The staff is inadequate as per ratio laid down. The deficiency should be removed and report made to this office.
- 6) Two/One more graduate teacher(s) should be added to the staff.

The Index No. allotted to your school is being intimated to you separately. You are now requested to remit to this office, if not already done, the annual fee of Rs. 10/- laid down under Regulation 20(5). On receipt of this, copies of the Board's literature will be supplied to you gratis. Copies of this Board's circulars issued during the current year have been supplied to you when your application for recognition was received. If any circulars are not received by you, the same may please be called for from this office.

Circular No. ABC/-13

Heads of schools are informed that the No. of candidates appearing at the S.S.C. Examination has been increasing very rapidly during the last 4 years. However, the time span at the disposal of the office for completing the various processes connected with the pre-examination work is the same all these years.

With a view to meet the situation, a via-media between the demand of the office for more time and the difficulty of the schools in filling in and forwarding admission forms to the Board's office before the usual dates, the appropriate authorities of the Board have decided that for March Examination when the volume of work is tremendous, the Heads of Schools may be requested to supply to the Board's office sufficiently in advance, names of regular Students (other than ex-students, teacher and Private candidates and candidates appearing with isolated subjects) to be sent up by the school for the S.S.C. Examination with their details i.e. names of subjects offered by the candidates, medium of answer, centre selected for the Examination etc. This information is to be supplied by the schools to the Board's office in the prescribed form, immediately the schools re-open after the Winter Vacation in 2nd week of November. Adequate copies of this form will be supplied to the schools next month. The Board's office will thus, be in a position to start the preliminary processes of work for March Examination immediately after the receipt of the information in respect of regular students of the schools. The application forms (admission forms) in respect of all candidates i.e. regular candidates (in respect of which the information is to be supplied in advance) as well as remaining candidates i.e. ex-students, private and teacher candidates and candidates appearing with isolated subjects, will be forwarded (by schools as usual) in January on the dates prescribed by the Divisional Board. The Heads of schools are requested to take particular care to see that all application forms of regular candidates, are tagged together by a thread separately in one bunch and in order in which they are listed at the time of forwarding the requisite information. The applications of remaining candidates, i.e. candidates other than regular students may be tagged separately as usual.

So far as March, 1968 Examination is concerned, the Heads of schools should send advance information in the prescribed form so as to reach this office on the days between 15th and 18th of November, 1967. Ten copies of the blank forms (with heading "Statement showing the details required for punching the data in respect of candidates sent up for the S.S.C. Examination of March/October, 196__") will be supplied by the office to the Heads of schools by the middle of ensuing October i.e. before the schools close for Winter Vacation. Subsequently at the time of actually forwarding applications, if there be some minor changes like deletion of a name, deletion of a subject etc. the same shall be specially brought to the notice of the office by Heads of schools in a separate letter while forwarding the application forms of individual candidates for admission to the Examination, in January, 1968.

Even a cursory look at the specimen form of the Statement when received by the schools will reveal that the columns as are



provided in the printed application form for admission to the Examination, are horizontally reproduced in this statement only with a slight change in their order.

The following points may please therefore, be taken note of by the Heads of the secondary schools while filling in the details in the prescribed statement:

- 1) Code No. and other information required while filling in the details are printed on the reverse of the statement for ready reference. The details should be filled in carefully.
- 2) A separate form is to be used for each of the three categories of the candidates and for each of the centres viz. 1) non-exempted candidates, 2) exempted candidates, 3) isolated candidates.
- 3) The information is to be submitted in the prescribed form which is printed on bond paper. The adequate copies of the form will be supplied to the schools by this office. Equal No. of copies of the form but printed on thin paper (School record copy) will also be supplied to the schools to enable them to maintain office copy on their record.

Further detailed information will be sent along with the blank forms which will be supplied by the middle of October.
