### NOTES ON AUDIT REPORT

- There can be some element of personal nature in the expenses like Telephone expenses, Shop expenses and Travelling Expenses debited to Profit & Loss Account, however quantification of the same is not possible.

records maintained and explanation given by the management regarding salaries and other outstanding provisions as on 31-03-2022.
