The H.M. has informed that though the expenditure is increasing day by day, the management proposes to keep the rise at a very minimum level, and hence has informed that a very much minimum rise is proposed, and that the revised fee should be Rs. 43,300/- (Rs. Forty-Three Thousand Three Hundred only) i.e. Tuition Fees of Rs. 37,300/- & Term Fees of Rs. 6,000/- for the next two academic years, that is academic year 2022–2023 and the academic year 2023-24.
