With reference to your letter No. 9634 dated 22-11-1958 on the subject noted above.

2. In the circumstances stated by you, you are allowed to open a Secondary School at Mahalunge Padwal, Tal. Ambegaon, Dist. Poona teaching VIII only through Marathi medium on the following conditions.

1. An adequate suitable and well ventilated and lighted accommodation is provided for the school. Similarly an adequate sanitary arrangement are also made.
2. An adequate furniture, teaching aids, Science equipment and that for Physical Education, Drawing etc. is provided.
3. Sufficient play ground is provided.
4. Teacher's and pupil's libraries are furnished with adequate No. of books to start with.
5. A trained graduate with at least 5 years teaching experience is appointed as the Head Master and arrangements for the teaching of Science, Drawing, Hindi, and Physical Education and other subjects are made by appointing suitable qualified and trained teachers of these subjects.
6. Fees are charged at the prescribed rates and if they are charged at higher or lower rates, permission of the Department is obtained for the same.
7. The management undertakes to abide by the rules and regulation of the department and to carry out the suggestions made by the department from time to time.

3. It is also requested that the management might be requested to build up an adequate Reserve Fund within a period of 3 years.

4. The question of recognition and grant to the ~~Sch~~ School will be decided on merit when the school is actually started and inspected by the department. A report regarding opening of the new School and the arrangements actually made about accommodation staff, ~~xx~~ furniture, library, the No. of pupils enrolled by Std. etc. should please be made to the office by the 20th ~~xx~~ June 1959 at the latest.

5. It should also be noted that no grant (even taken) grant can be paid to the school unless it is duly registered under the prescribed Acts.
