studies at the -- Introduction

Sir, Madam,

The question of the introduction of the subject 'Military Studies' in Std. VIII-XI of the secondary schools in Western Maharashtra was under the consideration of Government. It has now, been decided to introduce the subject 'Military Studies' as an optional subject in Std. VIII-XI of secondary schools in Western Maharashtra as an experimental measure from the year 1965-66. The subject (Military Studies) has already been included in Group VI of the S.S.C. Scheme i.e. one of the optional groups. The 4 periods allotted, in Std. IX and X, to the study of an optional subject leading to an optional subject at the S.S.C. Examination may, be utilised for this subject 'Military Studies'. As regards Std. VIII, 4 periods may be found for this subject by suitable adjustment of the periods allotted to other subjects.

2/- A copy of the syllabus to be followed for the teaching of the subject is enclosed herewith.

3/- You are requested to take suitable action accordingly.

Syllabus for Military - Studies (Infantry)

NOTES:-

- 1) This syllabus is drawn taking into consideration an Infantry Unit only. Those who have completed at least 2 years of the Junior N.C.C. Course or those who have completed training in the prescribed syllabus will be held eligible to offer this subject at the S.S.C. Examination. Ex-students who have completed the N.C.C. course may take the Examination in the subject provided they offer the subject within two years from the date of their being discharged from the N.C.C.
- 2) It comprises the major portions of the Junior Division N.C.C. syllabus prescribed for boys and girls. All these periods may be taken outside the school time-table in the morning. Training in these subjects can mostly be carried out outside the class-room, yet periods of theoretical nature may be taken inside the class-room.
- 3) Arms drill and Section Leading are to be taught to boys only. Home Nursing is meant for girls only.
- 4) Each class will have 128 periods of 40 minutes each for a session of 8 months. i.e. 16 periods per month and 4 periods per week (Vide the Block Training Programme given below)
- 5) The standard of passing will be 40% for the theory paper and 50% for the practicals.
- 6) While the schools should encourage candidates to use English as the medium of for the written examination, Hindi is also permissible as the medium for the written paper. For practicals, the medium should be Hindi or English.
