RESOLUTION : The question of Bringing on aided basis the Marathi
medium secondary School; started by the Maharashtriya Mandal,
Pune from the year 1970-71 on no grant-in-aid basis was under
consideration of Government for some time past. Government is
now pleased to direct that the Marathi medium secondary school
started by the Maharashtriya Mandal, pune at Gultekadi, Pune-9
from the year 1970-71 should be brought on aided basis as per
rules with effect from the year 1975-76 (i.e. it should be paid
non-salary grant on the basis of the expenditure incurred in
1975-76 and the salary grant on the basis of the expenditure for
the current year, during the year 1976-77). The Director of
Education, Maharashtra State, Pune should take necessary action
to bring the school on aided basis according and to pay the
non salary and salary grants during the year 1976-77.

2. As per normal procedure, the Salary grant is payable to
the management of non-Government Secondary Schools by credit to
the individual accounts of the teaching and non-teaching staff
concerned through Cooperative Banks as laid down in the scheme
sanctioned under Government Resolution, Education Department
No. SSN-1867/76142-G, dated 29.5.1973. Since the salary for the
period from March 1976 (paid in April 1976) till October, 1976
paid in November 1976 must have already been drawn by the teaching
and non-teaching staff concerned from the management, the
expenditure incurred by the management on this item should be
reimbursed to the management by the Director of Education,
Maharashtra State, Pune after due verification and after
satisfying about the actual expenditure incurred on payment of
salaries. The salary grant for the month of November, 76 should
also be released like-wise so as to avoid any inconvenience to
the staff of the School. Similarly, the Non-Salary Grant on the

Basis of the expenditure incurred during 1975-76 should be paid to the management in accordance with the revised procedure during the current financial year. The payment of salary to the teaching and non teaching staff through Co-operative Banks should be made with effect from December 1976 that is the Salary for the month of December 1976 should be paid in the month of January, 1977 through Co-operative banks.

3. The expenditures on this account should be debited to the budget head " 277-Education- B-Secondary(k)-Assistants to Non-Government Secondary Schools (4) schemes in the five Year plan (1) grant-in-aid for the development of ordinary secondary schools" Demand No.70 and should be met from the provision made thereunder during the current financial year.

4. This resolution issues with the concurrence of the Finance Department vide its Un official reference No. 2322/ Exp-5, dated 17.9.76.
