

Sir,

Permission is granted provisionally to open Std. IX in your school from June 1968 subject to fulfilment of the following conditions before opening of the school for the ensuing academic year.

- 1) A trained graduate with five years teaching experience in Secondary schools, out of which at least two years should be post training service is appointed as Head Master of the School.
- 2) A trained science graduate (B.Sc.B.Ed.) is appointed.
- 3) The services of qualified teachers such as Jr. /Sr.H.S.S./D.T.C/ C.P.Ed, are secured.
- 4) Adequate furniture and equipment such as dual desks, black boards, tables, chairs, work tables, etc, of approved pattern, sets of science apparatus and phy. education equipment are purchased.
- 5) Necessary additional teaching aids etc, are provided.
- 6) Rs. 150/- is spent on the purchase of library books (for teachers and pupils)
- 7) Satisfactory accommodation for class rooms, science laboratory, with proper ventilation and lighting is provided.

2. It should be noted that the proposed higher standard should not be opened unless all the conditions laid down in para 1 are fulfilled. If the conditions are not fulfilled, the provisional permission now granted, may not be confirmed. A detailed report regarding the fulfilment of these conditions should be submitted to this office immediately.





Please refer to Government Resolution ~~on~~ E.S. & S.W.D.
No. SSN-3870/86806-E(II) dated 27-9-1971 on the subject
mentioned above.

As per Government orders contained in para 4 of the
Government Resolution the excess trained graduate staff is
to be adjusted against the future vacancies. It was referred
to Government whether the appointments of Graduate/Trained
Graduate teachers made by the management last year are to be
adjusted as per above orders or they can be continued during
the year 72-73 as their appointments cannot be considered
as fresh one. Government have now clarified that temporary
graduates and Trained Graduates in service even in excess
as on the last working day of the 2nd session of the
academic year 1971-72 should not be removed from service
as a result of issue of Government orders under Government
Resolution referred to above. They can be considered as
temporary approved teachers.

The above position should be made clear to all the
Secondary Schools under ~~the~~ your jurisdiction.


