
Sir,

I am directed to forward herewith the application received from Pandurang International English School, at Pimpale Saudagar, Tal. Haveli, Dist.Pune run by V.H.B.P. Pandurang Kate Pratishatan, at Pimpale Saudagar, Tal. Haveli, Dist Pune alongwith enclosures in original to **CBSE**, New Delhi and to state that this Government have “No Objection” to accord affiliation to the school subject to fulfillment of the following conditions.

1. This No objection certificate will remain valid only for a period of 3 years. It will be binding on institution to get renewal of No Objection Certificate after a period of every three years. The first, No objection certificate will be issued at the Government level and the renewal of No objection certificate will be done after every three years at the level of concerned Deputy Director of Education.
2. The State Government reserves the right to withdraw the above certificate at any time without giving prior notice and without assigning any reason if any deviation of rules reported in future and the management falls to comply with the instructions of the State Government.
3. Admission should be made with the bonafide dates of birth certificate.
4. The management should collect the tuition fee and special fee etc. as prescribed by Fee Regulation Committee appointed by the State Government .
5. The strength in classes should be as per rule in force prescribed for English medium schools.
6. The management should follow the State syllabus for Classes from 1 to 5th.for the subjects History and Geography and for other subjects the school shall follow the syllabys prescribed by the respective Board/Council.
7. The school should follow the three language formula till 8th Standard and Marathi as II language.

8. The District Educational Officer or his nominee should be invited when the management makes recruitment of candidates for various categories of posts.
9. Staff salaries should be paid as per Government Scales of pay.
10. The management should not collect donations either from the students or from parents.
11. The management should implement the provident fund scheme.
12. No pupil studying in the school now be put to hardship for continuing in the same school.
13. It will be mandatory for the school to provide information about the details of classes and number of students to Education Officer (Primary and Secondary) before 31st August of each academic year.
14. No classes should be opened without prior sanction /permission from the Education Officer (Primary and Secondary).
15. The management shall follow the traffic and safety guidelines indicated by the police. Fire Services and the Transport Department from time to time and other orders of transport department for safe transportation of school children should be scrupulously followed.
16. The management should provide fire protection arrangement as prescribed in the National Building Code of India part IV fire Protection 1997 and it's amendments from time to time.
17. They should abide by the State Government Acts, rule, regulations and orders issued from time to time.
18. The school shall not be eligible for any kind of financial grant-in-aid from the Government and must be run only on self financing basis.
19. The no objection certificate is applicable till class XII; Provided the school must apply to renewal after a period of every 3 years as mentioned in clause (1) .
20. The State Government reserves the rights to carry out academic /audit inspection of the school. It will be mandatory to the school to provide any information at any time required by the Government. Please forward us a copy of the affiliation when granted to this school for our record.


Sir,

I am directed to forward herewith the application along with enclosures in original received for “ **Pandurang International English School, at. Pimpale Saudagar, Dist. Pune ” Run by “ V.H.B.P Pandurang Kate Pratishatan at.Pimpale Saudagar, Dist. Pune .”** and to state that this Government has no objection for C.B.S.E affiliation to school for Std. I to XII subject to fulfillment of various conditions laid down in the Government Resolution, School Education and Sport Department, No. NOC 2009/(663/09)/SE-1 dated 20/6/2012 as well as following conditions :-

1. Like all other schools in the State, Article 18 & 19 of the Right of children to free and Compulsory Education Act, 2009 and its schedule as well as Rules, orders, Notifications and Circulars etc. issued by State Government from time to time under this Act will also be applicable to the said school.
2. Institution shall abide by the provision of Section 12(1)(C) of RTE Act,2009 and Maharashtra RTE Rules 2013.
3. RTE Act 2009 provides for Inclusive Education thus children with special needs (CWSN) called “Divyang” shall be part of every class in the school. However “Divyang” children need special policy pronouncements. The State of Maharashtra is framing and issuing various policies in this respect. Government recently issued Resolution No. Mise 2015/(119-A)/SD-6 Dated 8th January,2016 in this regard, this Govt. Resolution is abiding. All directives, decisions and policies shall be abided by all school of all boards including international boards.
4. State’s all educational acts, rules, orders and policies made time to time will be applicable to the said school.
5. Curriculum of the State or respective Board shall be compulsory from 1st to VIII Standard.
6. Marathi language subject shall be taught from I to VIII Standard.
7. Staff salaries shall not be paid lesser than the Schedule ‘ C ’ of Maharashtra Employees Of Private School (Conditions of Service), Regulation Act,1981

8. The management shall follow the traffic and safety guidelines indicated by Circular No. 21748/DI/97 dated 16/2/1998 and No. PRE-2008/506/11/ Prashi-1 dated 14/7/2011 & other orders of transport department for safe transportation of school children should be scrupulously followed. The management shall provide fire protection arrangement as prescribed in the National Building Code of India, Part-IV Fire 1997 and there are amendments made from time to time.
 9. The School shall conduct 3 tests annually for all children upto Standard VIII and provide information about children achievements in SARAL database as per the provisions of Pragat shikshanik Maharashtra Government Resolution dated 22nd June, 2015.
 10. Childwise information as sought in SARAL and every other information as sought in U-DISE shall be provided by the school from time to time as demanded by the State Authorities.
 11. Institution shall abide by the policy and Maharashtra Education Institutions (Regulation of Fees) Act, 2011 made by the State Government regarding Regulation of fees.
 12. Indian History especially "History" related to Maharashtra" shall be taught in the school. Failing which this No Objection Certificate shall be withdrawn.
 13. The Complaint Redressal Committee regarding sexual harassment at school premises should be formed as per government Resolution, woman and child department No. मकचौ-२०१३ / प्र.क्र.६३/मकक, Dated 19.6.2014 and subsequent provisions in Act and Rules.
 14. The State Government reserves the rights to withdraw the above certificate at any time without giving prior notice and without assigning any reason if any deviation of rules reported in future and the management falls to comply with the instructions of the State Government.
