POINTS DISCUSSED:

- 1) The meeting commenced with a short prayer by Ms. Priya Shah.
- 2) The Principal Sr. Shareena extended a warm welcome to the present P.T.A. members and wished them a prosperous New year ahead. Mrs. Deepmala read out the minutes of the previous meeting held online with the discussion of various points and detail reduction of school fees for different classes from Std I to XII with the Parents opinion on the same.

3) Principal Sr. Shareena then informed the P.T.A members about the meeting with B.E.O. and Tehsildar regarding the collection of school fees at Vadgaon which was attended by the Manager and the Principal of the school. The school management was informed by the B.E.O. to conduct meeting with the P.T.A. members and then finalise the final reduction in the amount of school fees to be given to the students.

4) The Principal also explained the difficulties of the school management in payment of property taxes, electricity bill and water supply which amounted to a huge bill. Along with this the teachers salaries have to be paid in full. Thus the only source to meet out the expenses is collection of school fees.

5) The Manager Sr. Magline explained the points discussed by the Principal in Marathi for better understanding. Manager also added that the school land is owned by school management and he instead of rent the school has to pay property taxes which amounts in lakhs and a fine of 2% was imposed for the rebate given by the previous C.E.O. on the property tax to be paid. Hence the collection of Maintenance fees is essential.

6) The Principal then explained the details of Exam and Tz kids charged by the school from the students and its necessity. The Principal also asked suggestions on collecting pending fees of the previous year. She invited Parents suggestions regarding the points discussed.

PARENTS SUGGESTION :

- 1) Mrs. Anupriya Khadije read out the G.R. given by the Tehsildar Mr. Madhusudan Barge regarding the collection of tuition fees only. She also appreciated the school management and the staff members for having taken lot of efforts for the reduction of school fees and online studies of the students been taken very meticulously by the teachers. She only requested the Principal to call the students of std \bar{x} to school to write the papers as the students have lost writing practice since last eight months.
- 2) Mrs. Ujwala Borade suggested that all the Parents should be informed about the change in the fee structure as it difficult for them to communicate and convince the same to all the parents.
- 3) Mrs. Nimbalkar also appreciated the school for its efforts and made a humble request to try to make reduction in the Term fees.
- 4) Mrs. Souam Bhegade suggested to take every parents' opinion regarding the collection of fees and its reduction. Thus appropriate decision could be taken.
