

Subject:- Opening of Higher Std. XI from June 71

Reference: Your letter No. — .

Sir,

Permission is granted provisionally to open Std. XI in your school from June 1971 subject to fulfilment of the following conditions before opening of the school for the ensuing academic year.

- (a) A trained graduate with five years teaching experience in Secondary Schools, out of which at least 2 years should be post training service is appointed as Head Master of the School.
- (b) A trained Science graduate (B.Sc., B.Ed.) is appointed.
- (c) The services of qualified teachers such as Sr./Jr.H.S.S. D.T.C./ C.P.Ed. should be secured.
- (d) Adequate furniture and equipment such as dual desks, Black Boards, tables, chairs, work tables etc. approved pattern, sets of science apparatus and phy.edn. equipment should be purchased.
- (e) Necessary additional teaching aids should be provided.
- (f) Rs. 500/- should be spent on Library Books (for teachers and pupils)
- (g) Satisfactory accommodation for class rooms, science Laboratory, with proper ventilation and lighting should be provided.

2. It should be noted that the proposed higher standard should not be opened unless all the conditions laid down in para 1 are fulfilled. If the conditions are not fulfilled the provisional permission now granted, may not be confirmed. A detailed report regarding the fulfilment of these conditions should be submitted to this office on or before 5/7/71.
