Minutes of the meeting -

- 1) To consider the minutes of the meeting held on 13th October 2016 - The minutes of the meeting held on 13th October 2016 were read by the secretary of the PTA. The minutes were confirmed & approved by the members of the association.
- 2) To consider the annual report of activities - The report regarding the activities covered by the school throughout the year was read by the secretary of the PTA. The report was confirmed and appreciated by the members.
- 3) Information regarding the final examination - The necessary information regarding the final examination was given. The tentative dates and schedule of the examination was discussed with the members.

4) Information regarding the school timing during the SSC examination - Information regarding the change in the school timing during the SSC examination was given. It was informed that Gurukul High School is having SSC examination center therefore, it is necessary to vacate the school premise half an hour before the examination. Considering the timing of SSC exam the English medium school is keeping half a day during that schedule. The time schedule and dates were given to members.

5) Revised fee structure for the academic year 2017-18 - The president of the PTA has forwarded the proposal for the increase in fees for the next academic year 2017-18 by 10% to compensate the increasing need of expenses towards the teachers salary and other school related expenses.

The following resolution has been placed in the PTA meeting held on 20th February 2017 at Gurukul English Medium School.

Resolution (Resolution No. 3)

It was proposed by the President of the Parent Teacher Association Ms. Manisha Kalgude that to compensate the school related expenditure towards the salary and school related expenses like Building rent, Furniture & equipment, Electricity bills, Cleaning & Sanitation, Examination, picnic, celebration and activities, printing & Stationary, repairs and maintenance an increase in fees is necessary. Subsequent to the Budget submitted by Ms. Manisha Kalgude for the academic year 2016-17 the expenditure for the salary and other school related expenditure was Rs. 34,83,754/- out of the total collection of fees Rs. 24,00,000/-. For the next academic year 2017-18 an estimated expenditure

towards teachers salary and other school related expenses is approx. Rs. 39,36,000/- . As per the present fee structure the approx. fee collection will be 32,68,800/- which is insufficient to meet the increased budget

Therefore, the fee structure increase by 10% for the primary and secondary section is proposed.

Sanction Order (Year 2017-18)

- ① According to the budget submitted by the school to the Parents Teachers Association, out of total fee collection of the academic year 2016-17 i.e. Rs. 24,00,000/- the total expenditure for the salary and other school related expenses were Rs. 34,33,754/-.

For the next academic year 2017-18 the fee collection on the basis of existing fee rates will be approx. 32,68,800/- & expenditure for the teachers salary and other school related expenditure like rent, cultural activities, picnic, Cleanliness, repair and maintenance, furniture etc. are expected to approx. Rs. 39,36,000/-

Accordingly, after the discussion on the fee increase proposal presented by the school, we are giving consent to the said proposal through the PTA to increase the fees by 10% in both primary and secondary sections.

4) Information regarding the starting of new activities for the academic year 2018-19 under the development planning

a) From the next academic year school has planned to provide mobile application for the parents to keep the track about their wards attendance, late coming, school related notices activity schedule and report regarding activity completions students participation, HW completion & submission, tests etc. The members were informed about the charges of the application which would be covered under activity fees.

After few discussion all members unanimously agreed for the implementation of the activity and gave their permission

b) Also the members were made aware about the planning of English Language Development activity by Karadi path Pvt. Ltd. to improve the reading & speaking skills of students for std. 4 to 10 from the next academic year.

Members were also made aware about the charges of activity tentatively Rs. 650/- per annum towards the Demonstration kit for the students and support from the Company.

Further it is informed the parents have been given several reminders and sufficient time period for the fee submission by the school. But it is observed that these parents have not taken the matter seriously or showed any interest in clearing the dues. In spite of the fee issues, the school has been to it that their ward is not affected by this & has still not taken any step which is stern. But looking into the matter of financial deficit it is become difficult for the school to give more exemption to these parents and bare the loss.

Therefore, the resolution regarding the action to be taken for such cases was made & put forth for the approval of the members.

Resolution (Resolution No. 10)

The president of the PTA, Ms. Manisha Kalgude informed the association that there are some parents who have not submitted their school fees from the academic year 2018-19 to 2020-21. The parents have been given several reminders and sufficient time period for the fee submission by the school. But it is observed that these parents have not taken the matter seriously or showed any interest in clearing the dues. In spite of the fee issues the school has been to it that their ward is not affected by this and has still not taken any stern step.

But now that the current academic year is about to end it is impossible to ignore the dues anymore & carry forward the admission of these students. Therefore, it is proposed to the Association that in case if school takes any strict action against such cases the PTA members would support the school.

After some discussion, it was unanimously resolved to give permission to the school authorities to take any kind of appropriate action on such parents and that the school could terminate or withhold their admission for the next academic year.

7) Any other - No points were discussed in any other.

After resolving some queries of the members the meeting was ended by the vote of thanks given to the members for attending the meeting.
