Subject No 2 : Fees Fixation for year 2022-23
2023-24

First of all, the secretary of the committee Mrs. Supriya Gaikwad read the Maharashtra Government

Gazette dated 13th April 2016, The School fees were not increased due to Corona Period, But due to Parent's financial crises and Corona Period fees were decreased by 15%.

In order to increase the fees for year 2022-23 and 2023-24, Secretary firstly presented the members, that School has not increased the fees for last four years.

It was suggested that the school budget should be increased to spend on computer, net projector, sports equipments etc.

According to the Government rules school has decided to increase only for class 5th and above. The School fees for Primary section will be same. There is no increase in fees from last 4 years.
