#### **Agenda No. (5): To decide the school fees for the academic year 2024-25.**

The Headmistress of the school put forth the proposal of annual school fees for the A.Y. 2024-25 before all the members of e-PTA. She further informed that as per the RTE Act 2009, the school can revise the school fees after every two academic years with the hike of 15% in the fees. She further added that the Management of Vasundhara Institute of Education and Social Welfare, Pune has aim to provide the school education in less amount of fee as compared to any other private permanently unaided English medium schools in Pune city. The Management and the staff of the school always try to strives hard for giving value-based education and also organizing non-academic activities for overall development of our students with an ultimate goal of better bonding among themselves and with the school.

The management of the school is running the school by managing expenses within the school fees only. The main expenses of the school are staff salary, school building rent, electricity, online school work and record, stationary, students' exams & other activities etc. The HM updated the parents that during the last two academic years, the Management has spent sizable amount on school development & upgradation like new play-ground equipment, school entrance area decoration, new roof on the top floor, painting of all the rooms & benches, school digital record system, CCTV system, biometric attendance system, Student and Staff's digital Identity cards, and other maintenance of school infrastructure. Even, the manual ramp has been replaced by installing new hydraulic ramp at the front porch area of the school.

The HM further expressed her view that it is utmost necessary now to improve the financial side of school for its progressive development in every field and hence after a gap of two years, a revision in the school fees by nominal increase of 15% is proposed for the A.Y. 2024-25.

The members expressed their satisfaction with the school development & for further smooth running of the school aggreded on the proposal kept by the Headmistress. After the discussion, the members passed the following resolution for revision in school fees for A.Y. 2024-25.













**Resolution No. (5):** After the elaborate discussion on the proposal of revision in school fees put up by the Headmistress, the e-PTA members unanimously approved and passed the resolution that,

- 1) The school's annual total fee will be Rs. 27,600- (Rupees Twenty Seven Thousand Six Hundred only) per student for A.Y. 2024-25.
- 2) The break-up of the total fees per student per year is approved as follows-  
Tuition Fee : Rs. 27,000/-  
Term Fee : Rs. 500/-  
Other Fee : Rs. 100/-

- 3) The total annual fee Rs.27,600/- can be paid in two instalments i.e. Rs.14,000/- before 31st July 2024 and the balance amount Rs.13,600/- before 31st December 2024.

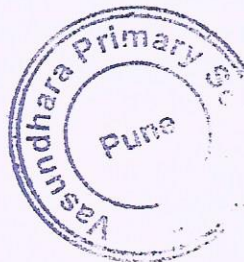
