On permanently no grant basis.

As per Government letter Education, Employment and Youth Services Department No. SSN 1279/66597(4247-N) VIII-XXXVI dated 21st June, 1979, permission is hereby granted to your management to open new secondary school at the place with medium and standard as given below:

The above school is permitted to be opened on permanently no grant basis from June, 1979, subject to the condition that the management gives a clear undertaking that they will not seek any Government grant or reimbursement of fees on behalf of E.B.C. concession holders at any time in future. The undertaking should be signed by the President and the office bearers of the management and should be submitted to the office immediately.

1. The management should deposit Rs.5,000/- for each class in authorised Bank
2. The management should appoint trained graduate teachers on the staff of the school.
3. The management should provide adequate and sufficient furniture, library-books, Science equipment and other contingencies.
4. Any other conditions mentioned in the Rules No.3 of S.S.Code required to be fulfilled for recognition.
5. On receipt of the report regarding the fulfillment of the conditions, regular permission will be given by this office.
