



### • Agenda 4: Fee approval for the sessions 2024- 25 & 2025-26

Principal Mam informed that for last couple of years there is no increase in School Fees. For the year 2023-2024, 2024-2025 same fee structure was being followed.

School management has decided to the same fees will be applicable for the academic year 2024-25. The above proposal has been considered by the Executive Parents Teachers Association (hereinafter referred to as "EPTA"), keeping in mind the various factors mentioned in "section 9" of the Maharashtra Educational Institutions (Regulation of Fees) Act, 2011 (hereinafter referred to as a "Said Act") and on finding the aforesaid proposal to be reasonable the EPTA has approved and fees applicable for the academic year 2023-24. The approved fees will be applicable for the academic session 2024-25 and 2025-26.

Mr. Subhash Rathod, Management Representative told the parents that - as per the fee regulation act the fees can be incremented after every two years hence the next fee revision is due for academic years 2023-24 and 2024-25 by 15% of the earlier approved fees but considering the present situation sympathetically we propose to keep the same fee structure as approved in 2022 for one more year that is 2025-26. He further added that school has always been with parents and this gesture of not revising fees shows out bonding with our parents.

### Proposal of fee structure was approved by all parent's representatives.

The Management of SPDSM, vide its resolution dated 29.12.2024 has taken the decision of the fee structure for Academic Year 2025-2026 as detailed:


