

- In our opinion the Balance sheet as on 31st March 2023 is in agreement with the Books of Account maintained by the Shivneri Army Primary School Account Subject to Observation made in (ii) below.
- (ii) We report our observation / Comments / Discrepancies / Recommendations below
  - a. Certificate of holding cash on 31st March 2023 and Bank Reconciliation Statement (BRS) as on that date was available.
  - b. The Security Deposit account showed balance of Rs 11,25,113 as on 31<sup>st</sup> March 2023. This account carries the Security Deposit from Students and Teachers.

    It is highly recommended to do the exercise of reconciling the balance of security deposit with the strength of teachers and students, every month.
  - c. The Balance sheet is showing Fixed Deposits of Rs 37.28 Lacs. It is advisable to obtain the relevant interest Certificate from Bank, to verify whether any Tax Deduction at Source (TDS) of Income Tax, was done by the Bank. In case of Tax deduction, the Income Tax law provides for filing of Income Tax Return and claim the refund of the amount deducted by Bank.

#### (iii) Subject to above

- a. We have obtained all the Information and explanation, which to the best of our knowledge and belief necessary for the purpose of audit.
- b. In our opinion proper books of account have been kept at the office of 24 Maratha PRI, Aundh Military Station, so far as appears from our examination of books.
- c. In our opinion and to the best of our information and according to the explanation given to us the said accounts give a true & fair view for the balance sheet.
