(1) A trained graduate with five years teaching experience in Secondary Schools, out of which at least two years should be post training service is appointed as Head Master of the School.

(2) ~~The~~ A trained science graduate (B.Sc. B.Ed.) is appointed.

(3) The services of equalified teachers such as Sr./Jr. H.S.S. D.T.C. /C.P.Ed. are secured.

(4) Adequate furniture and equipment such as dual desks, black boards, tables, chairs, work tables etc. of approved pattern, sets of science apparatus and phy. education equipment are purchased.

(5) Necessary additional teaching aids etc. are provided.

(6) Rs. 200/- is spent on the purchase of library books (for teachers and pupils).

(7) Satisfactory accommodation for class rooms, science laboratory, with proper ventilation and lighting is provided.

2. It should be noted that the proposed higher standard should not be opened unless all the conditions laid down in para 1 are fulfilled. If the conditions are not filled, the provisional permission now granted, may not be confirmed.
