In the circumstances reported permission to open Std. IX school from June 65 is granted provisionally subject to fulfillment the following conditions before the Opening of the school for the ensuing academic year.

1. A trained graduate with five year's teaching experience is appointed as the Head Master of the school.
2. A trained science graduate or at least a B.Sc. is appointed.
3. The services of qualified teachers to teach Hindi (H.S.S.), Drawing (D.T.C.) and Physical Education (D.P.Ed.) should be secured.
4. Adequate furniture and equipments such as desk, Black boards, tables, chairs etc. should be purchased.
5. Necessary additional teaching aids of Social studies and science etc. should be provided.
6. Rs. 300/- should be spent on the purchase of library.
7. Necessary additional accommodation (for class rooms, science, lab. etc.) with proper ventilation and lighting should be provided.
8. Efforts should be made to increase the no. on roll at least up to 30 in the Std. IX.

It should please be noted that the proposed higher std. should be opened unless all the conditions laid down in para 2 above are filled to the satisfaction of the Department. If the conditions are filled by you the provisional permission may not be confirmed. A detailed report regarding the fulfillment of the above conditions should be submitted to this office on or before 20-6-65 without fail.

3. The services of qualified teachers such as Sr.H.S.S.D.T.C. D.P.Ed.C.P.Ed. should be secured.
4. Adequate furniture and equipment such as dual desk Black Board tables etc. of approved patterns such as science apparatus etc. should be purchased.
5. Necessary additional teaching aids should be provided.
6. Rs.500/- should be spent on Library books.
7. Satisfactory accommodation for class rooms, Science Lab. etc. should be provided.

It should be noted that the proposed higher std. should not be opened unless all the conditions laid down in para 1 are fulfilled. If the conditions are not fulfilled the provisional permission now granted may not be confirmed. A detailed report regarding the fulfillment of these conditions should be submitted to this office on or before 10-6-66.


