With reference to your application dated 10.6.62, on the subject noted above, I have the honour to say that your management is permitted to open a secondary school at Kirkee teaching Standards V-VIII only through English medium with effect from June, 1962 on the usual conditions (vide Grant-in-aid Code Rule 3).

The permission granted is also subject to the following conditions:-

- 1) that the school will not get ^{any} grant from the Department i.e. it will be treated as unaided school.
2. It should be noted that the question of recognition to the school will be decided on merit when the school is actually started and inspected by the Department within one month of the opening of the school. The date of opening of the school, the arrangements actually made in respect of accommodation, staff, furniture, library, the No. of pupils enrolled in each standard etc. should be reported to this office and the Educational Inspector of the District.

This is to inform you that Proposal for School Self-Recognition – online application no. 2023777432270 was submitted however the proposal has been rejected and objection has been raised for the following points

1. Order of Name change for Primary Section.
 2. Primary School recognition order copy
 3. High School Recognition order

1. Permission had been granted to the school under the name of St. Joseph's Convent School. There was no separate order issued by the Education Department for the Primary Section.
 2. Initially St. Joseph Boys School was a Co-Education Institution. The Society of Carmelites decided to Bifurcate the Girls school from the Boys School, hence they acquired permission for Bifurcation of the two schools. Permission had been granted to the school under the name of St. Joseph's Convent School. The previous Co-Ed school was granted permission to function by the Zilla Parishad and later permission was Bifurcation was granted, hence no separate permission was granted to the Primary Section. The Order of Bifurcation is treated as the First Recognition Copy.
 3. With effect from the year June 1962, the Director of Education permitted the management to open a secondary school for teaching Standards V-VIII and an order had been passed for the same. Therefore, a copy of the permission granted by the Zilla Parishad for opening of new Secondary School has been attached for reference.

Kindly consider the above points and grant Self Recognition for St. Joseph's Convent Primary School, Khadki.
